1. IEEE 802 criteria for standards development (CSD)

The CSD documents an agreement between the WG and the Sponsor that provides a description of the project and the Sponsor's requirements more detailed than required in the PAR. The CSD consists of the project process requirements, 1.1, and the 5C requirements, 1.2.

1.1 Project process requirements

1.1.1 Managed objects

- a) The definitions will be part of this project.
- b) The definitions will be part of a different project and provide the plan for that project or anticipated future project.

Item c) is applicable to this project because this project will specify profiles that define the use and configuration of functions specified in other IEEE 802 standards, thus, relies on the managed objects specified by the referred standards.

1.1.2 Coexistence

1.2 5C requirements

1.2.1 Broad market potential

Each proposed IEEE 802 LMSC standard shall have broad market potential. At a minimum, address the following areas:

- a) Broad sets of applicability.
- b) Multiple vendors and numerous users.
- a) IEEE 802.1 Time-Sensitive Networking (TSN) gives an opportunity to unify networking for Automotive In-Vehicle Ethernet deterministic networks. TSN is the foundation to provide interoperability and connectivity for Automotive applications on converged networks to simultaneously support operational traffic that has pre-determined latency requirements. However, the breadth of choices in the use of the TSN features inhibits the interoperability of products designed for a particular market. By narrowing the focus, this profile expands the market for bridges, end stations, network interface cards, and integrated circuits. The specification of the use of TSN features in Automotive networking scenarios via TSN profiles is beneficial for Tier 1&2 suppliers offering and/or developing TSN products as well as for the users of Automotive automation technologies, e.g., in order to ease interoperability and deployment.

IEEE 802.1 Time-Sensitive Networking (TSN) gives an opportunity to unify networkingfor industrial automation. TSN is the foundation to provide interoperability andconnectivity to industrial applications on converged networks to simultaneously supportoperations technology traffic and other traffic. However, the breadth of choices in the useof the TSN features inhibits the interoperability of products designed for a particular market. By narrowing the focus, this profile expands the market for bridges, end stations, network interface cards, and integrated circuits. The specification of the use of TSNfeatures in industrial networking scenarios via TSN profiles is beneficial for vendorsoffering and/or developing TSN products as well as for the users of industrial automationtechnologies, e.g., in order to case interoperability and deployment.

b) The Automotive OEM's considers TSN as the next generation Ethernet networking technology enabler to provide required deterministic latency, security and meet safety requirements for networking within the vehicle. The TSN profiles for Automotive are essential for this.

Many industrial automation players consider TSN as the next generation networkingtechnology in smart manufacturing. TSN profiles for industrial automation are essentialfor them.

1.2.2 Compatibility

Each proposed IEEE 802 LMSC standard should be in conformance with IEEE Std 802, IEEE 802.1AC, and IEEE 802.1Q. If any variances in conformance emerge, they shall be thoroughly disclosed and reviewed with IEEE 802.1 WG prior to submitting a PAR to the Sponsor.

- a) Will the proposed standard comply with IEEE Std 802, IEEE Std 802.1AC and IEEE Std 802.1Q?
- b) If the answer to a) is no, supply the response from the IEEE 802.1 WG.
- a) This standard only selects protocols, procedures, managed objects already specified by other standards, e.g., IEEE Std 802, IEEE Std 802.1AC and IEEE Std 802.1Q.
- b) Not applicable.

The review and response is not required if the proposed standard is an amendment or revision to an existing standard for which it has been previously determined that compliance with the above IEEE 802 standards is not possible. In this case, the CSD statement shall state that this is the case.

1.2.3 Distinct Identity

Each proposed IEEE 802 LMSC standard shall provide evidence of a distinct identity. Identify standards and standards projects with similar scopes and for each one describe why the proposed project is substantially different.

1.2.4 Technical Feasibility

1.2.5 Economic Feasibility

Each proposed IEEE 802 LMSC standard shall provide evidence of economic feasibility. Demonstrate, as far as can reasonably be estimated, the economic feasibility of the proposed project for its intended applications. Among the areas that may be addressed in the cost for performance analysis are the following:

a) Balanced costs (infrastructure versus attached stations).

- b) Known cost factors.
- c) Consideration of installation costs.
- d) Consideration of operational costs (e.g., energy consumption).
- e) Other areas, as appropriate.
- a) The well-established cost balance between infrastructure and attached stations will not be changed by the proposed standard.
- b) The cost factors are known for the IEEE 802 standards that will be used by the proposed standard.
- c) There are no incremental installation costs relative to the IEEE 802 standards that will be used by the proposed standard.
- d) There are no incremental operational costs relative to the existing costs associated with the IEEE 802 standards that will be used by the proposed standard.
- e) No other areas have been identified.
