- 1. The chair read the patent policy and made the call for patents. There were no responses to the call for patents
- 2. Review of status:
 - a. 6 new maintenance items since March, 3 of which arrived in the last week
 - b. Qbg, aq were approved by Standards Board in March. The chair will ensure the items were included and then update the status.
 - c. Q-cor-2 has completed sponsor ballot and comment resolution will be addressed at the plenary.
- 3. New items (0032 & 0034) on AB were reviewed and it was agreed to initiate an 802.1AB Corrigendum PAR at the plenary to include these and other open items (0014 & 0027)
 - a. It was noted that AX-rev will likely include some text from AB that will then need to be removed. However, it was agreed to deal with this later given it will take considerably more time.
- 4. New item (0033) on aq was also submitted as a Q-cor-2 comment. It was agreed to consider inclusion of this as part of Q-cor-2.
- 5. New items (0036 & 0037) on MEP admin vs oper state and (0038) on user priority were noted.
- 6. It was noted that it is probably time to start thinking about another Q-rev to roll up the Amendments, include the final remnants from D and "reset the clock". A discussion will be had at the plenary as to if this is the right time.
- 7. Open items were reviewed and updated. See the slides and web-site for details and discussion.
 - a. 13 of the open maintenance items are included in Q-cor-2
 - b. 2 open maintenance items will be closed with the commenter given the option to pursue the issues further under Q-rev
