### Monday, 12 March

Meeting called to order at 9:00am.

Stephen Haddock presented the preliminary agenda for the week.

**802.1aq SPB:** Don Fedyk reported on the Sponsor ballot recirculation for 802.1aq-d4.5 Shortest Path Bridging. The ballot passed with no "disapprove" ballots. A single comment was received from the IEEE Editor stating that the draft has met all of the IEEE requirements. Two comments were submitted to the editor from a non-voter. One of these was a typographical error that can be corrected by the IEEE Editor during the publication process. The other comment was clarification of protocol behavior that, while correct, was not considered essential for this amendment. It will be submitted as a comment to 802.1bp since it is more significant for ECMP. The conclusion is that Sponsor ballot has successfully completed. It is anticipated that there will be a motion during the 802.1 Closing Plenary to forward 802.1aq to NESCOM.

**802.1ac MAC Service Definition:** John Messenger presented an editor's report and conducted comment resolution on the Working Group recirculation ballot for 802.1ac-d1.5 MAC Service Definition. The ballot passed with 100% approval. There were 8 editorial comments received.

### **DCB Minutes**

### Monday, 12 March, PM

The Task Group Chair (Pat Thaler) appointed Eric Gray to take meeting minutes.

The Chair reviewed IEEE 802 policies, including the patent policy, and issued a call for essential patents.

There was no reponse to the call for patents.

The Chair reported that P802.1Qbg and P802.1BR recirculations completed with 100% approval. Each had a comment from the editor that editorial coordination requirements had been met. P802.1BR had 4 additional comments. Comment resolution was conducted by Joe Pelissier and all 4 will be passed to the IEEE editor for consideration in preparing the draft for publication. The Chair asked if there were any objection to requesting P802.1Qbg and P802.1BR be sent to RevCom for approval.

This work relates to use of virtual machines in large-scale multi-tenancy data-center applications. The Chair pointed out that the description of the requirements for a VN Connect/Disconnect Notification was very similar to the capabilities of VDP.

The differences are that filter formats in VDP identify the Virtual Network by VN-ID (Group ID in 802.1Qbg) rather than a longer VN Name and support carrying MAC addresses but not IP addresses. Additional filter formats could be defined that address these differences. We discussed likely steps and a strategy for ensuring that the "right thing gets done in the right place."

Initial steps include having a number of us attend the BoF at the next IETF meeting (25-30 March, 2012). At some point we will probably want to have an Internet Draft that provides a "gap analysis" between VDP and VN Attach/Detach protocol requirements and how the gaps might be resolved.

Rakesh Sharma talked about issues that he feels are exposed by EVB. There were no slides and Rakesh indicated that he is just looking for feedback on the issues and proposals as to what - if anything - needs to be done about them.

The Chair then talked about future meetings and conference call proposals. The plan suggested was to have a couple of conference calls timed to allow us to be as certain as possible that we would (or would not) need to hold a DCB meeting in May and/or July - early enough to make plans accordingly, but late enough to ensure a minimum likelihood of late arrival of issues that might need to be addressed at a face-to-face meeting.

The dates proposed were: April 3rd and June 12th.

The chair asked if there were any objections to this plan. There were none.

The chair reminded attendees to register their attendance, and adjourned the meeting.

- future contribution to progress these or cause them to be withdrawn/rejected.
