Submitting documents

If you want to submit a document you are requested to: adhere to the style of the committee (see style of documents)

- include the Document number in the headers
- print the headers and footers on all pages
- bring **at least 100 copies to a plenary meeting and 70 copies to an intermediate meeting** and deliver to Vic Hayes prior to the meeting (e.g. by using a courier to the meeting place)
- include presentation material as an appendix if their contents differ from the body of the paper.

Document numbers are obtained from the chair via e-mail (vic.hayes@Utrecht.NCR.COM) or FAX (+31 3402 39125, Attention Vic Hayes)

NOTE: in addition to a paper copy, you are requested to submit an electronic copy on a 3.5" floppy, DOS format, in either Word, WordPerfect format; alternatively a copy in postscript is accepted.

Style of documents

Documents submitted to IEEE P802.11 should have the following format:

- on 8.5 x 11" paper, margins: top: 1", bottom 1", Left .75", Right .75". Print with gutter of .5"
- contain a header and a footer on each page

* the header is as follows: Times (New) Roman, 14 point, bold, line below:

Left: the month and year of issue

Right: the text "doc: IEEE P802.11-yy/nn", where yy are the last two digit of the year and nn are the digits of the document number

* the footer is as follows: Times (New) Roman, 12 point, line above

Left: the text "submission" Center: "page n", where n is the page number

Right: optionally your name and/or company name

The documents are loaded on the Apple server first and copied to the Twente server overnight.

Structure from readme on: subdirectories for ibmpc, macintosh, drop and RFMACSIM.

From ibmpc you will find subdirectories for 1990_docs, 1991_docs, 1992_docs, 1993_docs, 1994_docs, bulk_archive, editors, etc, excom, regul, issues, working, std.

Note that the files containing draft standards (in directory std) are protected by copyright and are therefore protected by a password which is only disclosed to members and participants of IEEE P802.11.
