The IEEE P802.11 standards working group is in the process of developing a standard, IEEE P802.11 Wireless LAN Medium Access Control (MAC) and Physical Layer (PHY) Specifications, that utilizes many technologies. Examples of used technologies are Radio transmission/reception, Infra-red transmission/reception both Direct Sequence as well as Frequency Hopping Spread Spectrum, CSMA/CA, RTS/CTS and medium control techniques. Draft D2.0 has been provided on a diskette to show the complete technology used now. As such, there is the possibility that this standard may be covered by patents or patents pending that you or your company hold. For your information, you will find on page 2 a list of individuals that participate or have participated in our committee and are working for your company.

The IEEE patent policy (as shown on page 2) requires a release letter such as the one shown on page 2. I would appreciate it very much if you or your company would provide such a letter.

Some companies have already submitted letters related to patents. However, most of them provided a statement relative to a particular proposal. Therefore, we are asking now for a letter with an explicit reference to the current draft and cited paragraph(s), clause(s) of relevance by patent applicability claim.

In view of the progress of the standard, we need to have this letter before October 24, 1995. If I have not received your letter before that time, I will report to the committee that you or your company does not hold Intellectual Property Rights.
