The March 6, 2000 opening plenary of IEEE 802.11 discussed the proposed PAR 802.16.3. The group passed the following motion with 24 approving, 0 disapproving and 4 abstaining.

Motion made by Bob O'Hara, second by Harry Worstel.

Motion: 802.11 strongly objects to the inclusion of unlicensed bands in the PAR for sub 11 GHz operation by 802.16. Because 802.11 covers outdoor operation for many services.

IEEE 802.11 respectfully requests IEEE 802.16 to reconsider the PAR content in the light of this objection.
