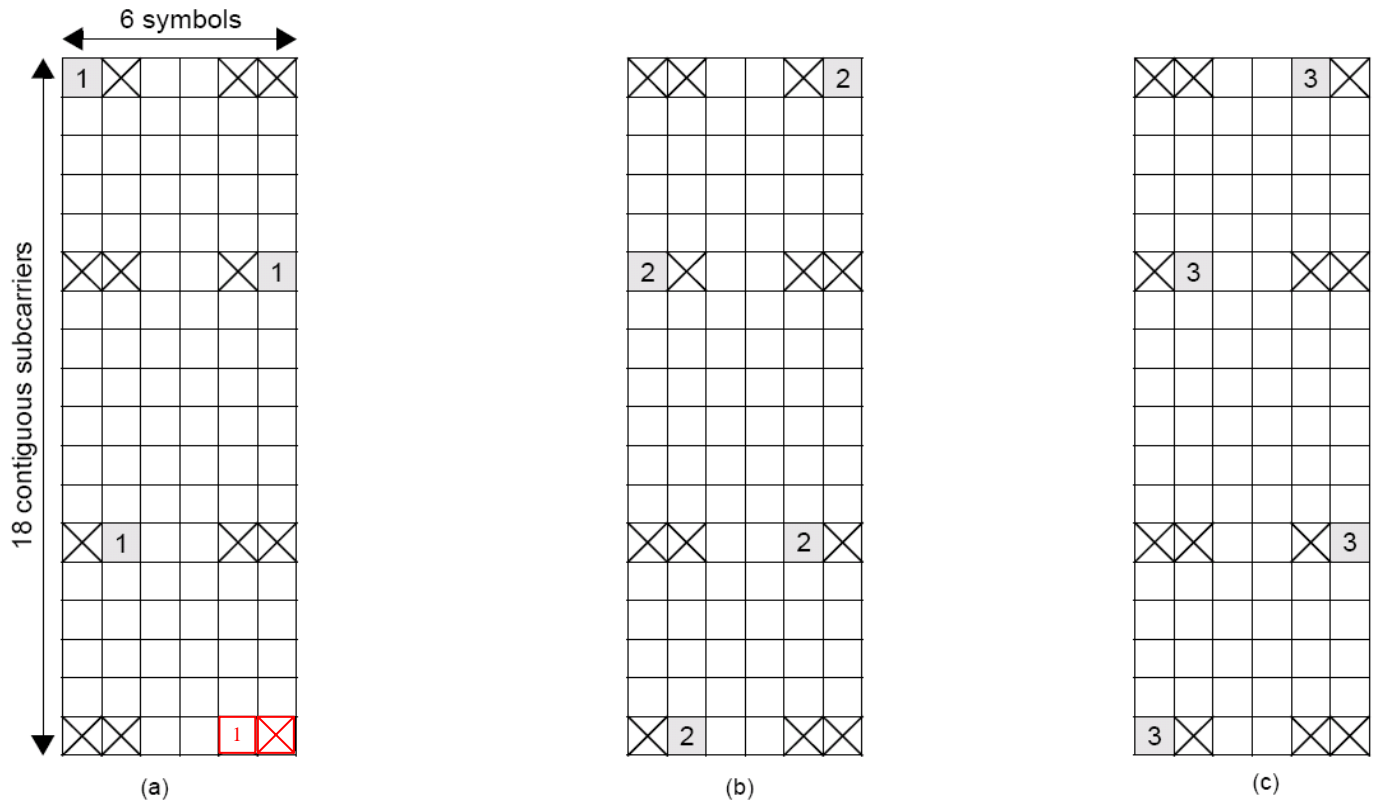


Figure 497—Pilot patterns for contiguous LRUs for 3 Tx streams
