## Abstract

Chairman Carl Stevenson called the March 2003 meeting of the RR-TAG at 2:57pm on Monday and identified a list of tasks for the group's review and potential action.

The group discusses and arrives at the following items and solutions:

- ARRL Concern they are attempting to provoke a confrontation on 2.4GHz spectrum. While considered a 'lose lose' situation, group feels there is no course of action beyond monitoring the plans and promulgating the data to regulatory and legislative individuals
- Canada MSS Measurements Contribution DoD is concerned and requesting issue's data on the proposal, we have received expert analysis data

The Chair, Carl Stevenson, calls the meeting to order at 2:57pm local

## Tuesday 11 Mar 03

Chair re-convenes TAG at 8:00am

Chair presents 802.18-03-014d0 for the group's review, discussion and approval.

Chair puts the document on appropriate WG servers and e-mails the reflectors of 802.11, 15, 16, and 20 asking for their review and motion approval at their plenary sessions.

John Notor presents data he has gathered overnight on impact of additional 2.4GHz allocation, it is "2.4GHz unlicensed extension analysis – jn031003.doc"

He identified the spectrum as allocated to MOBILE SATELLITE, and RADIODETERMINATION SATELLITE space to earth links.

The potential spectrum occurs in two blocks, 2483.5 - 2492.5 and 2498 - 2500 MHz, the skipped 5.5MHz block is currently allocated to MSS Ancillary Terrestrial Components (ATC). The R&O states that ATC systems shall be capable of operating over the entire 2483.5 - 2500MHz band. Currently 2483.5 - 2500MHz is listed as a protected band in 15.205.

Considering the nine MHz block, John voiced the opinion that this would afford a fourth non-ovelapping channel for 802.11b systems but has concerns with band edge spurious emission levels for 802.11g systems. He comments that 8802.15 systems would be able to use the spectrum for interference mitigation.

John will prepare a bullet list of how wireless 802 systems could benefit and will draft letter based on the data we discussed.

Chair asks for a discussion on RM-10666 (Petition by National Translator Association) based on the homework assignment. Peter Murray questions the need for commenting at this time and recommends waiting to see the Commissions actions and then respond to comments that result of any Notice. Discussion feels that consideration on this petition should be delayed until after determination of the NoI ET Docket 02-380 (Spectrum sharing TV channels with license-exempt devices). Chair will prepare a document for further discussion.

Andy Gowans presents four presentations on the current status of the UK RA:

- (03-015r0)802.18UK update on 5GHz Bands A&B
- (03-016r0)802.18UK update on 5GHz Band C
- (03-017r0)802.18UK update on OFDM in 2,4GHz
- (03-018r0)802.18UK update on BFWA above 11GHz

Currently the documents are in "Informal Input Documents" and will be put onto the server with the document numbers shown within the parenthesis.

In the process of changing EN300-328v1.4.1 from references to OFDM to Wide Band Modulation, expect final approval by the end of April 03

Approval of Band C for FWA is working toward approval by end of summer 03

They are considering 'Light Licensing' which will be more for tracking the number and location of installed sites as opposed to technical licensing. And, they currently have Electronic Licensing for some services.

The chair call for lunch recess at 12:25pm, RR-TAG will resume at 1:30pm

Chair calls the meeting back in session at 1:33pm.

Chair recommends review of Italy\_Translation and Canada\_MSS\_Meas\_Contrib\_WP4A while he attends CAC meeting schedule for 2:00-3:00pm

Reading of Italy paper appears to indicate general conformance with ERC DEC (99)23 with an exception of 5150-5250MHz band where TPC provision is not mentioned. Jim Raab and Andy Gowens volunteer to draft a letter of clarification.

The Canadian paper proposes a method on signal analysis to identify aggregate RLAN energy. Two accompanying documents are from the European Space Agency with their analysis of the proposed method. The US radar community is concerned with the viability of the proposal and is requesting comments on elements of the method. The group discussed which elements to prioritise and the data to be supplied.

Bruce Kraemer arrives with his update on the Korean spectrum proposal 802.11-03/186r0 Bruce comments that Korea is supportive of the WRC-03 AI 1.5 for RLAN allocation. ETRI = Electronics and Telecommunications Research Institute MIC = Ministry of Information and Communication

RR-TAG discusses the possibility of inviting them to come to Singapore and present their spectrum plans. Bruce will continue working with the Koreans and improve the communications with the RR-TAG and will report back on Thursday

Jim and Andy has a draft comment letter "Italy Clarification" and has e-mailed it to the Chair, whom will put it on the server for the group to review overnight.

The Chair also suggests continued thinking of inclusions into the Canadian comment letter.

Chair calls the meeting into recess at 5:11pm until 8:00am Wednesday

# Wednesday 12 March 03

Chair calls meeting back into session at 8:15am, and comments that the session will be breaking at 10:00am for the 802.11, .15 mid week plenary sessions.

Jim Raab presents the Italy clarification letter, and the group reviews and suggests minor changes.

Dave Hytha presents information on the BlueTooth SIG information DA 02-2152. He request RR-TAG support on 15.3 current channel hopping rules prevents hopping to overlapping channels. The HomeRF exception allows bandwidths up to 5 MHz wide signals. Currently plans are for bandwidths on the order of 1.4MHz at the 20dB points. This results in spectrum overlap, and would require either redefinition of the bandwidth specification to 14dB down or to permit the overlap. Dave will be providing a liaison letter requesting RR-TAG review and comment of the best approach to resolve the channelling issue. He indicates that a response is required in four weeks.

Denis reports that modification to the Canadian file has been lost and attempts to locate it on the machine have not been successful. He plans on re-constructing it overnight.

Chair discusses the ARRL plan for high power RLAN usage. He plans on doing simulation studies with several 100 Watt repeaters. His base plan is promulgate their plans and the results from his simulations. At this time it is premature to publish anything against their plan, better to wait and see what ARRL does.
