

#### **Guidelines for IEEE-SA Meetings**

- Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.
- Don't discuss the status or substance of ongoing or threatened litigation.
- Don't be silent if inappropriate topics are discussed... do formally object.

#### **Participation in IEEE 802 Meetings**


Participation in any IEEE 802 meeting (Sponsor, Sponsor subgroup, Working Group, Working Group, etc.) is on an individual basis

- Participants in the IEEE standards development individual process shall act based on their qualifications and experience. (https://standards.ieee.org/develop/policies/bylaws/sb\_bylaws.pdf section 5.2.1)
- IEEE 802 Working Group membership is by individual; "Working Group members shall participate in the consensus process in a manner consistent with their professional expert opinion as individuals, and not as organizational representatives". (subclause 4.2.1 "Establishment", of the IEEE 802 LMSC Working Group Policies and Procedures)
- Participants have an obligation to act and vote as an individual and not under the direction of any other individual or group. A Participant's obligation to act and vote as an individual applies in all cases, regardless of any external commitments, agreements, contracts, or orders.
- Participants shall not direct the actions or votes of any other member of an IEEE 802 Working Group or retaliate against any other member for their actions or votes within IEEE 802 Working Group meetings, see <a href="https://standards.ieee.org/develop/policies/bylaws/sb\_bylaws.pdf">https://standards.ieee.org/develop/policies/bylaws/sb\_bylaws.pdf</a> section 5.2.1.3 and the IEEE 802 LMSC Working Group Policies and Procedures, subclause 3.4.1 "Chair", list item x.

By participating in IEEE 802 meetings, you accept these requirements. If you do not agree to these policies then you shall not participate.



### Overview of IEEE 802.3 Standards Process (1/5)-Study Group Phase




## Overview of IEEE 802.3 Standards Process (2/5) – Task Force Comment Phase




# Overview of IEEE 802.3 Standards Process (3/5) – Working Group Ballot Phase

- Gain approval at the IEEE 802.3 WG, IEEE 802 EC, IEEE-SA NesCom and IEEE-SA Standards Board.
- SG only exists for 6 months
  - Extensions can be requested
  - Voted on by IEEE 802.3
  - Ratified by IEEE 802 EC
- Development of Objectives helps set the goals for the Task Force
- Consensus required to move forward
- Not a goal choosing a solution.

## Joint Meetings - Change 1-03/19

#### Specific text changes

#### Insert the following at the end of 3.3.2 Meetings and Participation:

IEEE 802.3 Task Forces may meet jointly at the discretion and agreement of the respective Task Force Chairs and the Working Group chair. Task Forces operating with membership rules for voting (see 3.3) cannot meet jointly.

Motions, other than approval of Joint Task Force meeting agenda and minutes, may only be taken in respect to a project in a joint Task Force meeting with the prior approval of the IEEE 802.3 Working Group.

#### Insert the following at the end of 3.4.2 Voting:

Motions are defined as either technical or procedural by the TF Chair, or the respective individual chairing a joint task force meeting.
