Chair noted he was giving this presentation from his chair perspective, and it should not be interpreted as support for any proposals.

Chair noted two timeline options, based on submittal of project documentation in July or Nov 2018. It was noted that the Sept 2018 IEEE-SA Standards Board Meeting occurs after the September Interim. So if there were no additional interim meetings added, per Option #1 (Submission in July), the first official task force meeting would be at the Nov Plenary.

Individuals expressed desire to submit documentation for consideration at July Plenary. Chair noted that individuals wishing to get other objectives added should be working towards getting objectives adopted in May, and Chair expressed desire that individuals use the ad hoc calls to present material prior to the May Interim meeting.

Chair noted that while developing responses to PAR project dates (Items 4.2 and 4.3) he reviewed the different objectives, and questioned whether the group should revisit the decision to generate a single a PAR, given potential different timelines for solutions. Chair noted that if two PARs were desirable, then two complete documentation packages need to be generated for the May meeting.
