Meeting Minutes SCC18 Adhoc March 28, 2018 1PM ET

13:01 Meeting called to order.

Adhoc Chair reviewed agenda slides, covered the IEEE patent policy and participation rules.

13:03 Chair informs the group that minutes for the previous meeting are posted, asked if anyone that wanted to review the minutes hadn't had the chance to review, and asked if there were any changes to be made to the minutes. None responded. Chair instructs the webmaster to change the status of the 3/21/18 minutes to approved.

13:04 Moving to the main agenda, reviewed a proposal to a consensus position: http://www.ieee802.org/3/ad_hoc/SCC_18/public/Proposal%20to%20Resolve%20the%20conflict%20between%20IEEE%20802.pdf. [include the PES statement to SCC18]. PES WLS needs time to work on this. They also require input.

- 1. IEEE 802.3 still supports an approve for FR 8932, FR 8859, and FR 8790, but now with the following comment.
 - a. IEEE could not reach consensus on this issue and therefore IEEE has no position on the matter of rated current versus nominal current. The primary issue of contention is how to handle the variations of current across the multiple conductors in a multi-conductor power circuit. This issue should be worked on and proposals submitted as public comments to the second revision.
- 2. If the vote remains abstain for FR 8932, FR 8859, and FR 8790, IEEE 802.3 supports the preceding text under a). as the accompanying comment.
- 3. With respect to FR 7892, IEEE 802.3 supports the text under a). as the accompanying comment.

The Chair asked if anyone on the call opposed this statement being forwarded to SCC18. None responded.

The next scheduled SCC18 adhoc meeting is April 4, 2018, 1PM ET.
