Adhoc Chair reviewed agenda slides, covered the IEEE patent policy and participation rules.

Chair informs the group that minutes for the meeting is posted, asked if anyone that wanted to review the minutes hadn't had the chance to review, and asked if there were any changes to be made to the minutes. The yellow text in sections 725.121, 725.144 and 840.160 was reviewed and discussed.

One text change was suggested for 840.160:

'Shall also be permitted to carry power for...' (drop the word circuits from the text). George will bring this up in the TG call tomorrow.
