Minutes of Interim Meeting, Nashua, NH, Sept .12-13, 2005

Monday, Sept. 12, 2005

The meeting was called to order at 8:35am by the Chair, Brad Booth. George Eisler was selected as recording secretary.

The agenda for the meeting was presented by the Chair.

The Chair then reviewed the Ground Rules for the Task Force. At 8:45am, the Chair read the IEEE-SA Bylaws on Patents in Standards as follows:

6. Patents

IEEE standards may include the known use of essential patents and patent applications provided the IEEE receives assurance from the patent holder or applicant with respect to patents whose infringement is, or in the case of patent applications, potential future infringement the applicant asserts will be, unavoidable in a compliant implementation of either mandatory or optional portions of the standard [essential patents]. This assurance shall be provided without coercion and prior to approval of the standard (or reaffirmation when a patent or patent application becomes known after initial approval of the standard). This assurance shall be a letter that is in the form of either:

- a) A general disclaimer to the effect that the patentee will not enforce any of its present or future patent(s) whose use would be required to implement either mandatory or optional portions of the proposed IEEE standard against any person or entity complying with the standard; or
- b) A statement that a license for such implementation will be made available without compensation or under reasonable rates, with reasonable terms and conditions that are demonstrably free of any unfair discrimination.

This assurance shall apply, at a minimum, from the date of the standard's approval to the date of the standard's withdrawal and is irrevocable during that period.

The Chair next reviewed topics inappropriate for discussion during IEEE meetings, as follows:

Don't discuss licensing terms or conditions
Don't discuss product pricing, territorial restrictions or market share
Don't discuss ongoing litigation or threatened litigation
Don't be silent if inappropriate topics are discussed Do formally object

The Chair then reviewed the IEEE Standards process and the status of the current draft. The Task Force will likely convene an interim meeting during the week of Oct. 17, 2005 in San Jose, CA. Regrettably, the March, 2005 802 Plenary will have to be relocated from its planned New Orleans site.

Sanjay Kasturia, the Editor, reviewed the status of the draft and launched directly into resolving comments submitted against D2.2 of 802.3an.

Comment resolution continued until a break for lunch.

The meeting resumed at 1:30pm with further comment resolution. Powell_1_0905, ungerboeck_2 _0905, and mcclellan_1_0905, all on the subject of start-up, were presented in conjunction with comments. Decisions were postponed pending further consultation among Task Force members led by B McClellan. Further comment resolution continued until the meeting recessed at about 6pm.

Tuesday, September 13, 2005

The meeting reconvened at 8:30am with continued comment resolution. Cmd53 table.pdf was posted in satisfaction of Comment 53 on D2.2.

The meeting returned to the consideration of comments relating to start-up;. mcclellan 2 0905 was presented as proposed resolution to a number of related comments.
