Mr. Daines indicated that the Task Force is nearing the end of its work. He reviewed the status of the project from Call for Interest through the latest Sponsor recirculation ballot.

There are 16 comments to consider including 3 rogue comments (received by the WG Chair after the sponsor ballot re-circulation had closed).
