### **Deferred Issues from D2.2 Comment resolution**

#### Improvements to the jitter measurement methodology

- A consensus seemed to be forming around: "aligning the means of each histogram then adding them together to obtain the jitter probability density distribution"
  - A consensus presentation on this change and the ensuing changes to the draft text is encouraged – we don't want to be word-smithing this at the March plenary !
- Re-order sub-clauses, so J4/JRMS and EOJ sub-clauses are adjacent
- EOJ sub-clause should use same CRU text as J4/JRMS
- COM parameter differences versus 802.3cd
  - Need a presentation on why these changes were made and their relevance to 802.3bs



## Participants, Patents, and Duty to Inform

All participants in this meeting have certain obligations under the IEEE-SA Patent Policy.

- Participants [Note: Quoted text excerpted from IEEE-SA Standards Board Bylaws subclause 6.2]:

- The above does not apply if the patent claim is already the subject of an Accepted Letter of Assurance that applies to the proposed standard(s) under consideration by this group
- Early identification of holders of potential Essential Patent Claims is strongly encouraged
- No duty to perform a patent search
