- Clause 108 (RS-FEC):
 - RS-FEC EEE rapid codeword marker mechanism is undefined.
 - Clause 49 hi_ber threshold is not compatible with the Clause 108 error marking.
 - Codeword marker values (BIP, pad)
- Clause 110 (CR):
 - Clause 74 FEC and no-FEC modes of operation and related specifications.
 - Clause 74 FEC mode PMD BER target
- Clause 73:
 - 25GBASE-CR/KR auto-negotiation parameters
