Agenda:

• Continuing discussion to try to complete the draft 0.6.

Preliminaries:

Patent statement was presented with no response from the participants.

So far, 9 people are attending the June 27th interim in Mountain View. There will be no Webex/phone, as per the directives from 802.3.

Discussion

- Yong made updates to 0.9 with today's comments which will become draft 1.0 for the June 27th 802.3cb Task Force Interim face-to-face meeting. The 1.0 draft will go out for review, the week of June 13th, and that review will close the Friday before the June 27th Interim, on June 24th. (http://www.ieee802.org/3/interims/mt_view_1_0616.html)
- We walked through the comments from Peter Wu, Rich Mellitz, and David Law. The document containing the comments is found on the 802.3cb TF Private page.
- Graphs will be changed to match 802.3 desired formatting, when a formal comment comes in (probably from Dan Smith). Yong requested the formal comment to read: "Wherever possible, prior adopted clause documents should be used as example for the formatting of plots." (Following Clause 69B is a good example.) Also will add, "All return loss plots to become logarithmic, and all plots will use the maximum of the equation, unless the plot represents 2.5G and 5G (a shared plot).
 - Dan will try to reformat these plots, using Matlab as the source. We need both the graphic source document (for future changes) and a bit mapped image output from that, for Framemaker inclusion.
 - The plan is to have these black and white plots, in proper format, by the June 27th interim.
- Discussed whether to duplicate 128C into 130C or make 130C stand-alone. Straw poll: Duplicate: 3, Annotate: 4, Abstain: 1.
 - Draft 1.0 will have annotation within 128C to cover any changes for 130C.

- The comment tool will be required when draft 1.0 is posted for review before the June 27th meeting. Dan will include this in a notice when the 1.0 posting notice goes out to the TF reflector. All comments against draft 1.0 require the use of the comment tool.
