Preliminaries:

Patent statement was presented with no response from the participants.

Presentation/Discussion:

- William showed his Clause 202 containing information from Clause 70/72.
 - o William touched on the need for the .7 sections from the PHY sub group
 - o Rich brought up problem of a closed eye for 5G. Tx emphasis and CTLE will work but how do we spec this? Possibly use Clause 85's pulse fit technique for resolution.
 - Clause 72 does not include an eye but it has test points.
 - Annex 83E actually has more utility for our channel with a connection in the middle. But replace the reference receiver with a pulse fit response.
 - Test fixtures explained in Clause 92.11. We need to make that an Annex in ours for additional utility by others and ease of use in our draft. De-embedding goes away with careful definition of the test fixtures.
- April 1st first draft from Macau contributions. April 4th hard deadline. We then have a week to finish editing on Draft 0.1. April 18th is a 2 week's review that closes on May 1st comments only.
- June 27th Interim becomes 1.0 review. Must be technically complete to meet Working Group Ballot at the July Interim. Editors will have about 2 weeks to prepare for WG Ballot.
- There is a technical issue with 2.5G SGMII being used for Lane 0 alignment. William says the alignment is built into the current draft. William and Yong will have an offline discussion.
