- 1. 27 comments received on D2.1. 11 Editorial, 7 Technical-Required, 9 Technical.
- 2. Unresolved negative comments from D2.0 will be carried forward unless the commenters agree that they are satisfied with the resolution.

Comment #20 – was closed and accepted in principle. The value of the 'SEC' test condition for the stressed receiver sensitivity tests of 25GBASE-LR and -ER will change to 1.5 dB. It is expected that this will need further review in sponsor ballot.

Comment #24 – to reduce the minimum extinction ratio for 25GBASE-ER was closed and rejected. The commenter attended by teleconference and requested a straw poll on this decision. **Straw Poll #1:** Do you agree with the proposed rejection of comment #24?

Y: 5 N: 2 A: 4 (including some via the phone)

It is expected that this will need further review in sponsor ballot.

Comment #25 – was closed and accepted in principle with a change of the TP3 FAIL limit for 25GBASE-ER to -26 dBm. However it is expected that this will need further review in sponsor ballot.

Comment #26 – to relax the minimum extinction ratio for 25GBASE-LR is a restatement of a previous comment (#63 against D2.0) which was rejected, rebutted and recirculated. The commenter was advised to try to build consensus at the March meeting. (See comment #24 above for a similar situation).
