2.6.2 Draft Standard Balloting Requirements

Before a draft is submitted to WG letter ballot it shall in addition have met the following requirements:



- It must be complete with no open technical issues.
 - It must be made available for pre-view by the membership at least 10 days prior to the Working Group meeting where the draft will be considered. If any changes are made to the draft after it was made available for pre-view, the changes shall be presented for review prior to the vote for approval to go to WG ballot.

- It must be formatted according to the IEEE style selected by the WG Chair. This style will be selected to minimize the editorial work required for publication of the draft.
- During a plenary week, it must be approved for submittal to WG ballot at the WG closing plenary.

For the WG letter ballot to be considered valid, abstention rate shall be less than 30%.
