## Guidelines for IEEE-SA Meetings

- All IEEE-SA standards meetings shall be conducted in compliance with all applicable laws, including antitrust and competition laws.
- Don't discuss the interpretation, validity, or essentiality of patents/patent claims.
- Don't discuss specific license rates, terms, or conditions.
  - Relative costs, including licensing costs of essential patent claims, of different technical approaches may be discussed in standards development meetings.
    - Technical considerations remain primary focus
- Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.
- Don't discuss the status or substance of ongoing or threatened litigation.
- Don't be silent if inappropriate topics are discussed... do formally object.

## Participation in IEEE 802 Meetings

#### Participation in any IEEE 802 meeting (Sponsor, Sponsor subgroup, Working Group, Working Group, etc.) is on an individual basis

- Participants in the IEEE standards development individual process shall act based on their qualifications and experience. (<a href="https://standards.ieee.org/develop/policies/bylaws/sb\_bylaws.pdf">https://standards.ieee.org/develop/policies/bylaws/sb\_bylaws.pdf</a> section 5.2.1)
- IEEE 802 Working Group membership is by individual; "Working Group members shall participate in the consensus process in a manner consistent with their professional expert opinion as individuals, and not as organizational representatives". (subclause 4.2.1 "Establishment", of the IEEE 802 LMSC Working Group Policies and Procedures)
- Participants have an obligation to act and vote as an individual and not under the direction of any other individual or group. A Participant's obligation to act and vote as an individual applies in all cases, regardless of any external commitments, agreements, contracts, or orders.
- Participants shall not direct the actions or votes of any other member of an IEEE 802 Working
  Group or retaliate against any other member for their actions or votes within IEEE 802 Working
  Group meetings, see <a href="https://standards.ieee.org/develop/policies/bylaws/sb\_bylaws.pdf">https://standards.ieee.org/develop/policies/bylaws/sb\_bylaws.pdf</a> section
  5.2.1.3 and the IEEE 802 LMSC Working Group Policies and Procedures, subclause 3.4.1 "Chair",
  list item x.

By participating in IEEE 802 meetings, you accept these requirements. If you do not agree to these policies then you shall not participate.
