

#### Participants have a duty to inform the IEEE

- Participants <u>shall</u> inform the IEEE (or cause the IEEE to be informed) of the identity of each holder of any potential Essential Patent Claims of which they are personally aware if the claims are owned or controlled by the participant or the entity the participant is from, employed by, or otherwise represents
- Participants <u>should</u> inform the IEEE (or cause the IEEE to be informed) of the identity of any other holders of potential Essential Patent Claims

## Early identification of holders of potential Essential Patent Claims is encouraged



#### **Ways to inform IEEE**

- Cause an LOA to be submitted to the IEEE-SA (patcom@ieee.org); or
- Provide the chair of this group with the identity of the holder(s) of any and all such claims as soon as possible; or
- Speak up now and respond to this Call for Potentially Essential Patents

  If anyone in this meeting is personally aware of the holder of any patent claims that are potentially essential to implementation of the proposed standard(s) under consideration by this group and that are not already the subject of an Accepted Letter of Assurance, please respond at this time by providing relevant information to the WG Chair



#### Other guidelines for IEEE WG meetings

- All IEEE-SA standards meetings shall be conducted in compliance with all applicable laws, including antitrust and competition laws.
  - Don't discuss the interpretation, validity, or essentiality of patents/patent claims.
  - Don't discuss specific license rates, terms, or conditions.
    - Relative costs of different technical approaches that include relative costs of patent licensing terms may be discussed in standards development meetings.
      - Technical considerations remain the primary focus
  - Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.
  - Don't discuss the status or substance of ongoing or threatened litigation.
  - Don't be silent if inappropriate topics are discussed ... do formally object.

#### Participation in IEEE 802 Meetings


Participation in any IEEE 802 meeting (Sponsor, Sponsor subgroup, Working Group, Working Group, etc.) is on an individual basis

- Participants in the IEEE standards development individual process shall act based on their qualifications and experience. (https://standards.ieee.org/develop/policies/bylaws/sb\_bylaws.pdf section 5.2.1)
- IEEE 802 Working Group membership is by individual; "Working Group members shall participate in the consensus process in a manner consistent with their professional expert opinion as individuals, and not as organizational representatives". (subclause 4.2.1 "Establishment", of the IEEE 802 LMSC Working Group Policies and Procedures)
- Participants have an obligation to act and vote as an individual and not under the direction of any other individual or group. A Participant's obligation to act and vote as an individual applies in all cases, regardless of any external commitments, agreements, contracts, or orders.
- Participants shall not direct the actions or votes of any other member of an IEEE 802 Working Group or retaliate against any other member for their actions or votes within IEEE 802 Working Group meetings, see <a href="https://standards.ieee.org/develop/policies/bylaws/sb\_bylaws.pdf">https://standards.ieee.org/develop/policies/bylaws/sb\_bylaws.pdf</a> section 5.2.1.3 and the IEEE 802 LMSC Working Group Policies and Procedures, subclause 3.4.1 "Chair", list item x.

By participating in IEEE 802 meetings, you accept these requirements. If you do not agree to these policies then you shall not participate.



## Overview of IEEE 802.3 Standards Process (1/5)-Study Group Phase




#### Overview of IEEE 802.3 Standards Process (2/5) -**Task Force Comment Phase**




## Overview of IEEE 802.3 Standards Process (3/5) -Working Group Ballot Phase





## IEEE P802.3cs Super-PON Objectives

- Provide Physical Layer specifications that:
  - Preserve the Ethernet frame format utilizing the Ethernet MAC
  - Support a BER of better than or equal to 10<sup>-12</sup> at the MAC/PLS service interface (or the frame loss ratio equivalent)
  - Support a passive point-to-multipoint ODN with a reach of at least 50 km with at least 1:64 split ratio per wavelength pair
  - Support at least 16 wavelength pairs for point-to-multipoint PON operation
  - Support the MAC data rate of 10Gb/s downstream
  - Support the MAC data rates of 2.5Gb/s and 10Gb/s upstream
  - Leverage existing EPON PCS and PMA to support the above MAC data rates
  - Support tunable transmitters
