#### **INSTRUCTIONS FOR THE WG CHAIR**

The IEEE SA strongly recommends that at each WG meeting the chair or a designee:

Show slides 1 through 4 of this presentation

#### • Advise the WG attendees that:

- IEEE's patent policy is described in Clause 6 of the IEEE SA Standards Board Bylaws;
- Early identification of patent claims which may be essential for the use of standards under development is strongly encouraged;
- There may be Essential Patent Claims of which IEEE is not aware. Additionally, neither IEEE, the WG, nor the WG Chair can ensure the accuracy or completeness of any assurance or whether any such assurance is, in fact, of a Patent Claim that is essential for the use of the standard under development.

#### Instruct the WG Secretary to record in the minutes of the relevant WG meeting:

- That the foregoing information was provided and that slides 1 through 4 (and this slide 0, if applicable) were shown;
- That the chair or designee provided an opportunity for participants to identify patent claim(s)/patent application claim(s) and/or the holder of patent claim(s)/patent application claim(s) of which the participant is personally aware and that may be essential for the use of that standard
- Any responses that were given, specifically the patent claim(s)/patent application claim(s) and/or the holder of the patent claim(s)/patent application claim(s) that were identified (if any) and by whom.
- The WG Chair shall ensure that a request is made to any identified holders of potential essential patent claim(s) to complete and submit a Letter of Assurance.
- It is recommended that the WG Chair review the guidance in *IEEE SA Standards Board Operations Manual* 6.3.5 and in FAQs 14 and 15 on inclusion of potential Essential Patent Claims by incorporation or by reference.

Note: **WG** includes Working Groups, Task Groups, and other standards-developing committees with a PAR approved by the IEEE SA Standards Board.





#### PARTICIPANTS HAVE A DUTY TO INFORM THE IEEE

- Participants <u>shall</u> inform the IEEE (or cause the IEEE to be informed) of the identity of each holder of any potential Essential Patent Claims of which they are personally aware if the claims are owned or controlled by the participant or the entity the participant is from, employed by, or otherwise represents
- Participants <u>should</u> inform the IEEE (or cause the IEEE to be informed) of the identity of any other holders of potential Essential Patent Claims

### Early identification of holders of potential Essential Patent Claims is encouraged





#### WAYS TO INFORM IEEE

- Cause an LOA to be submitted to the IEEE SA (patcom@ieee.org); or
- Provide the chair of this group with the identity of the holder(s) of any and all such claims as soon as possible; or
- Speak up now and respond to this Call for Potentially Essential Patents

If anyone in this meeting is personally aware of the holder of any patent claims that are potentially essential to implementation of the proposed standard(s) under consideration by this group and that are not already the subject of an Accepted Letter of Assurance, please respond at this time by providing relevant information to the WG Chair





#### **OTHER GUIDELINES FOR IEEE WORKING GROUP MEETINGS**

- All IEEE SA standards meetings shall be conducted in compliance with all applicable laws, including antitrust and competition laws.
  - Don't discuss the interpretation, validity, or essentiality of patents/patent claims.
  - Don't discuss specific license rates, terms, or conditions.
    - Relative costs of different technical approaches that include relative costs of patent licensing terms may be discussed in standards development meetings.

Technical considerations remain the primary focus.

Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.

Don't discuss the status or substance of ongoing or threatened litigation.

Don't be silent if inappropriate topics are discussed. Formally object to the discussion immediately.

  - Shall not direct the actions or votes of other participants or retaliate against other participants for fulfilling their responsibility to act & vote based on their personal & independently developed opinions
- By participating in standards activities using the "*individual process*", you are deemed to accept these requirements; if you are unable to satisfy these requirements then you shall immediately cease any participation

# IEEE-SA standards activities shall allow the fair & equitable consideration of all viewpoints

- The <u>IEEE-SA Standards Board Bylaws</u> (clause 5.2.1.3) specifies that "*the* standards development process shall not be dominated by any single interest category, individual, or organization"
  - This means no participant may exercise "authority, leadership, or influence by reason of superior leverage, strength, or representation to the exclusion of fair and equitable consideration of other viewpoints" or "to hinder the progress of the standards development activity"
- This rule applies equally to those participating in a standards development project and to that project's leadership group
- Any person who reasonably suspects that dominance is occurring in a standards development project is encouraged to bring the issue to the attention of the Standards Committee or the project's IEEE-SA Program Manager

### IEEE P802.3cy Greater than 10 Gb/s Electrical Automotive Ethernet PHY TF Objectives

- Preserve the IEEE 802.3/Ethernet frame format at the MAC client service interface
- Preserve minimum and maximum frame size of the current IEEE 802.3 standard
- Support full duplex operation only
- Define optional startup procedure which enables the time from power\_on=FALSE to a state capable of
- transmitting and receiving valid data to be less than 100ms
- Support a BER better than or equal to 10-12 at the MAC/PLS service interface (or the frame loss ratio
- equivalent)
- Support a data rate of 25 Gb/s, 50 Gb/s and 100 Gb/s at the MAC/PLS service interface
- Support optional Auto-Negotiation
- Support optional Energy Efficient Ethernet optimized for automotive applications
- Support operation in automotive environments (e.g., EMC, temperature)
- Do not preclude meeting FCC and CISPR EMC requirements

### IEEE P802.3cy Greater than 10 Gb/s Electrical Automotive Ethernet PHY TF Objectives

- Define the performance characteristics of an automotive link segment and an electrical PHY to support 25 Gb/s point-to-point operation over this link segment supporting up to 2 inline connectors for at least 11 m on at least one type of automotive cabling
- Define the performance characteristics of an automotive link segment and an electrical PHY to support 50 Gb/s point-to-point operation over this link segment supporting up to 2 inline connectors for at least 11 m on at least one type of automotive cabling
- Define the performance characteristics of an automotive link segment and an electrical PHY to support 100 Gb/s point-to-point operation over this link segment supporting up to 2 inline connectors for at least 11 m on at least one type of automotive cabling
- Support optional Clause 104 power over data lines on appropriate media

### IEEE802.3 Interim

- P802.3cy will hold Interim meetings on Sept. 21 & 28
- IEEE 802.3 September virtual interim has **no registration or meeting fee**
- 802.3 WG meeting is scheduled for Sept. 30
- Attendance credit per David Law
  - The rules do not provide for attendance credit toward membership for an electronic interim. The IEEE 802 Working Group P&P say, however, that 'Membership may be declared at the discretion of the Working Group Chair (e.g., for contributors by correspondence or other significant contributions to the Working Group).'.
