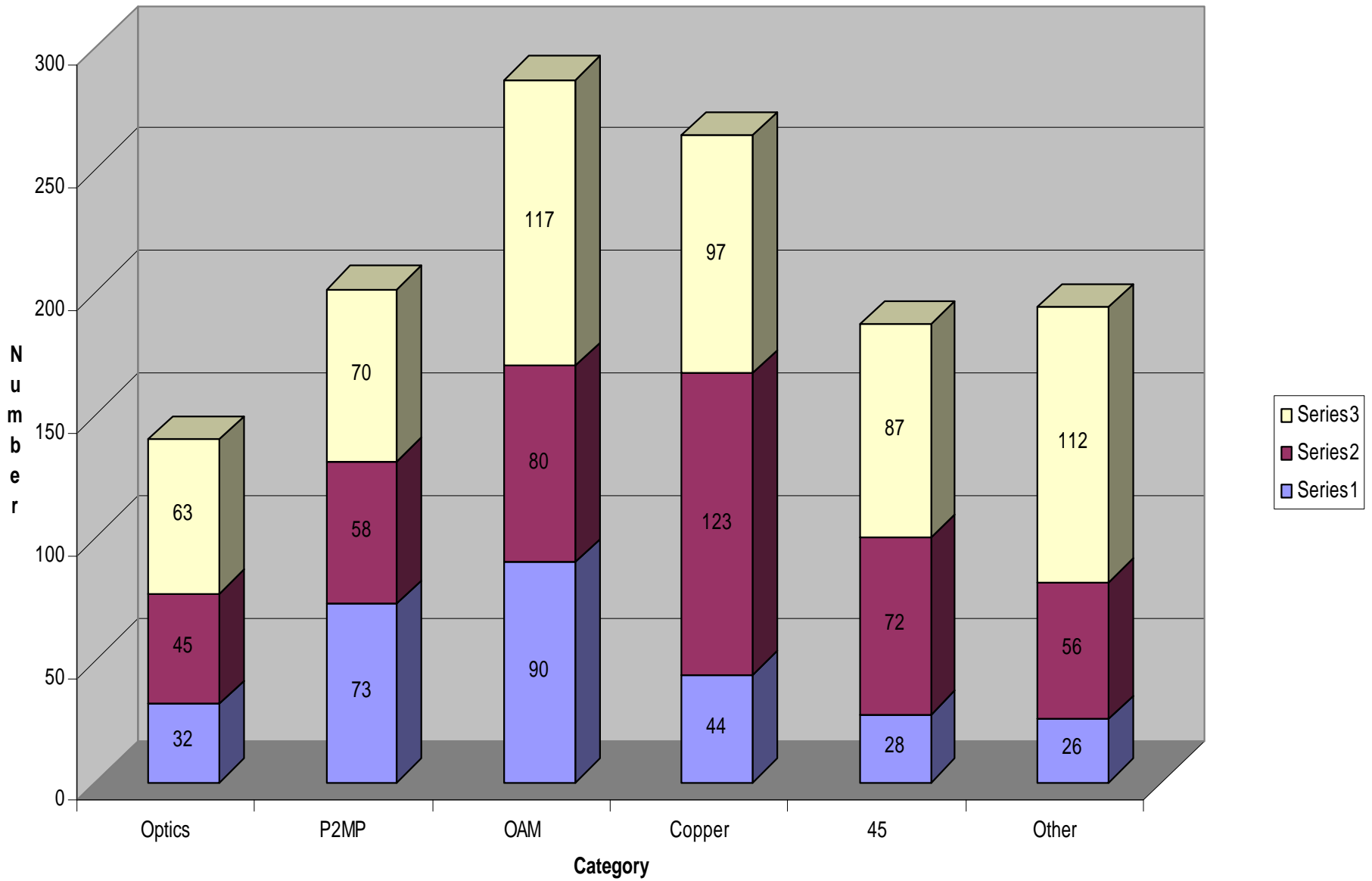

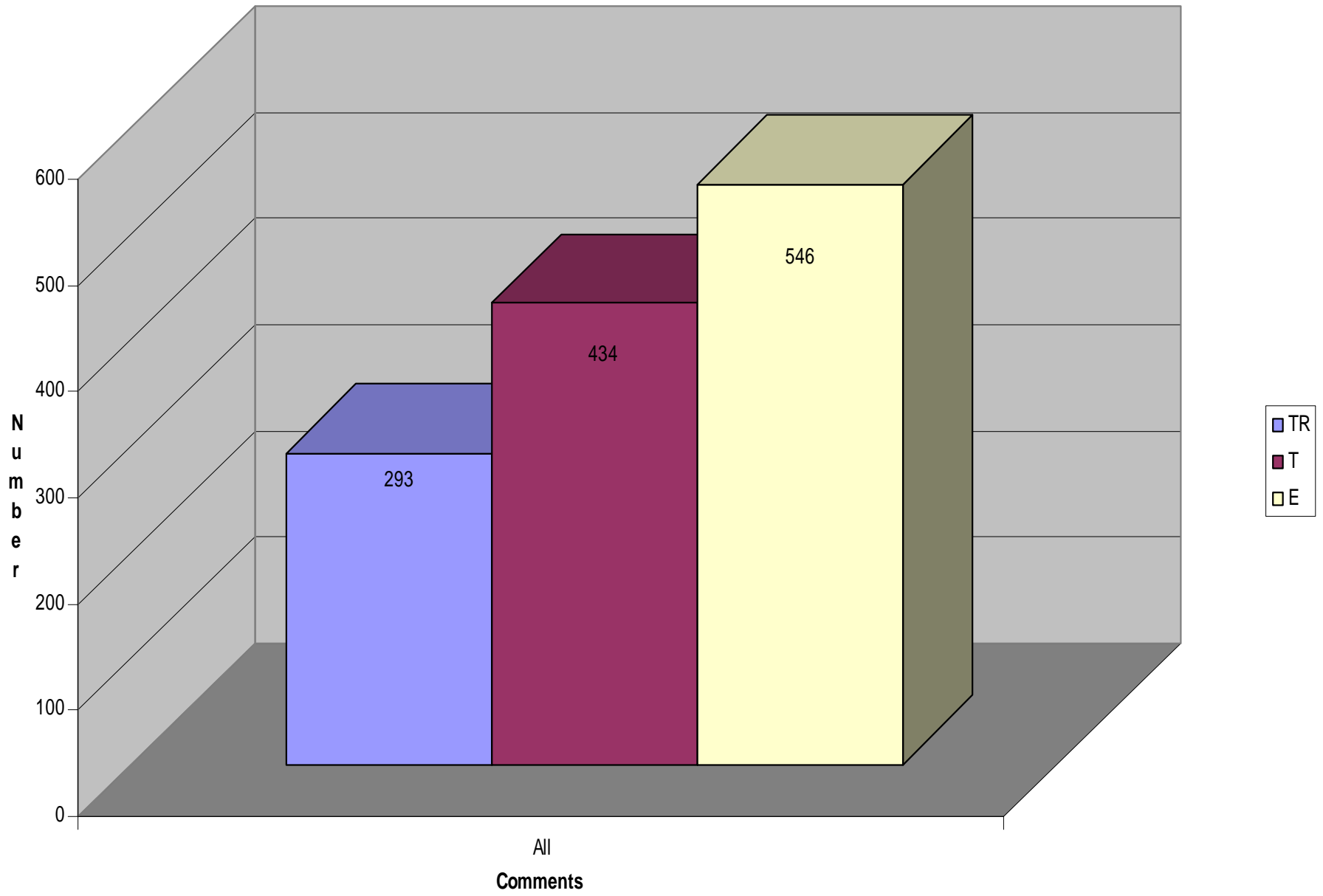

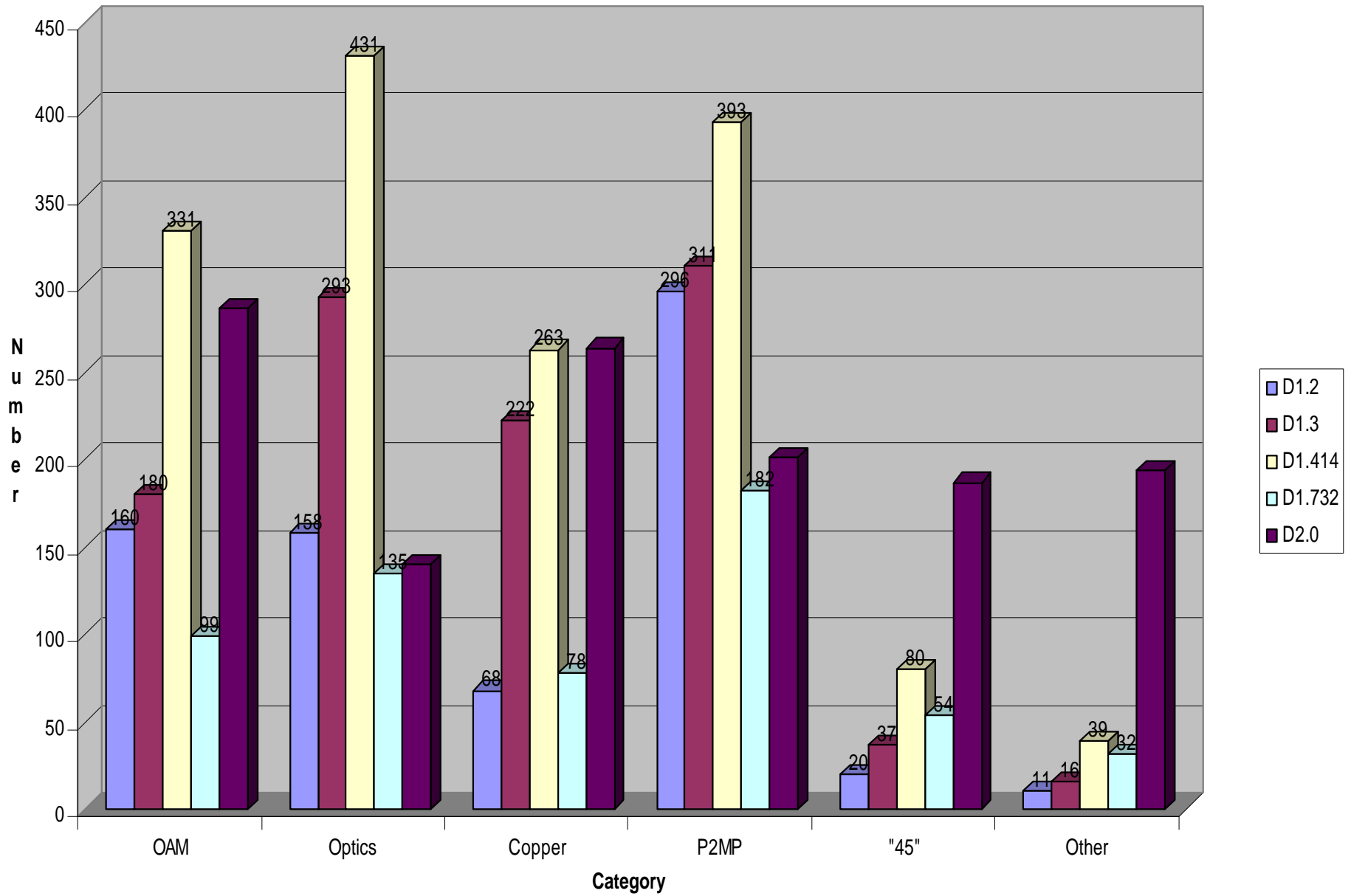
Comments by Category



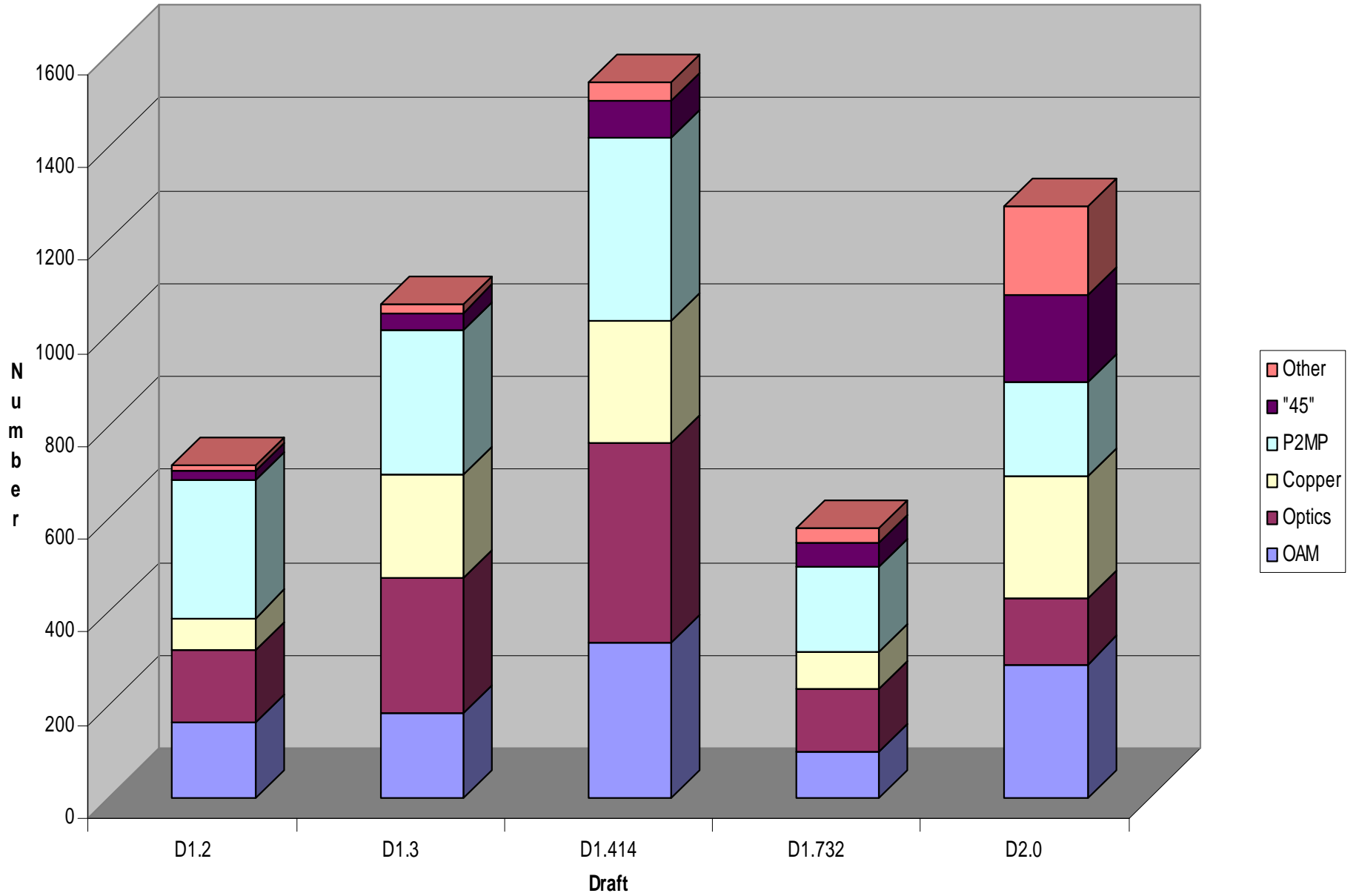
D2.0 Comments by Type



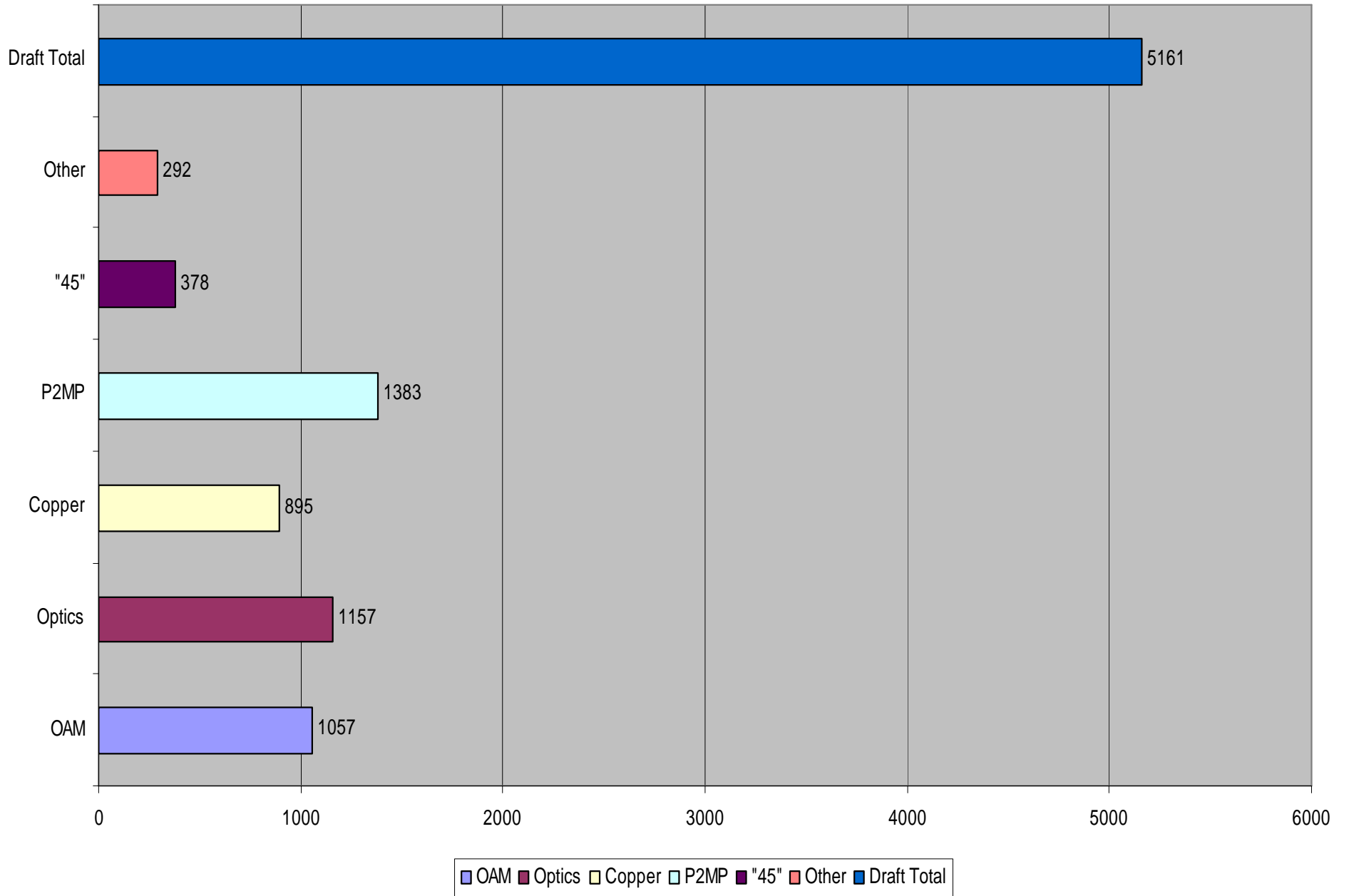
Comment composition by Drafts



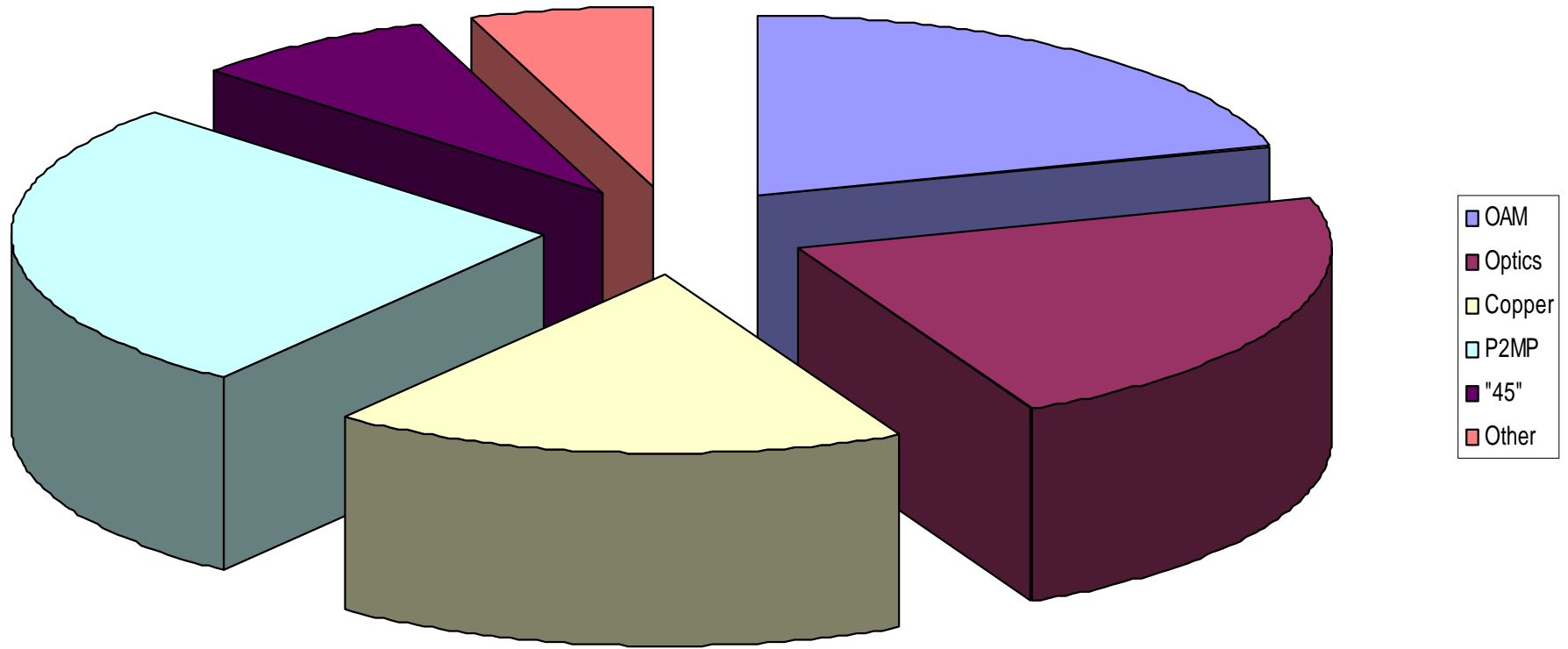
Total Comments by Draft



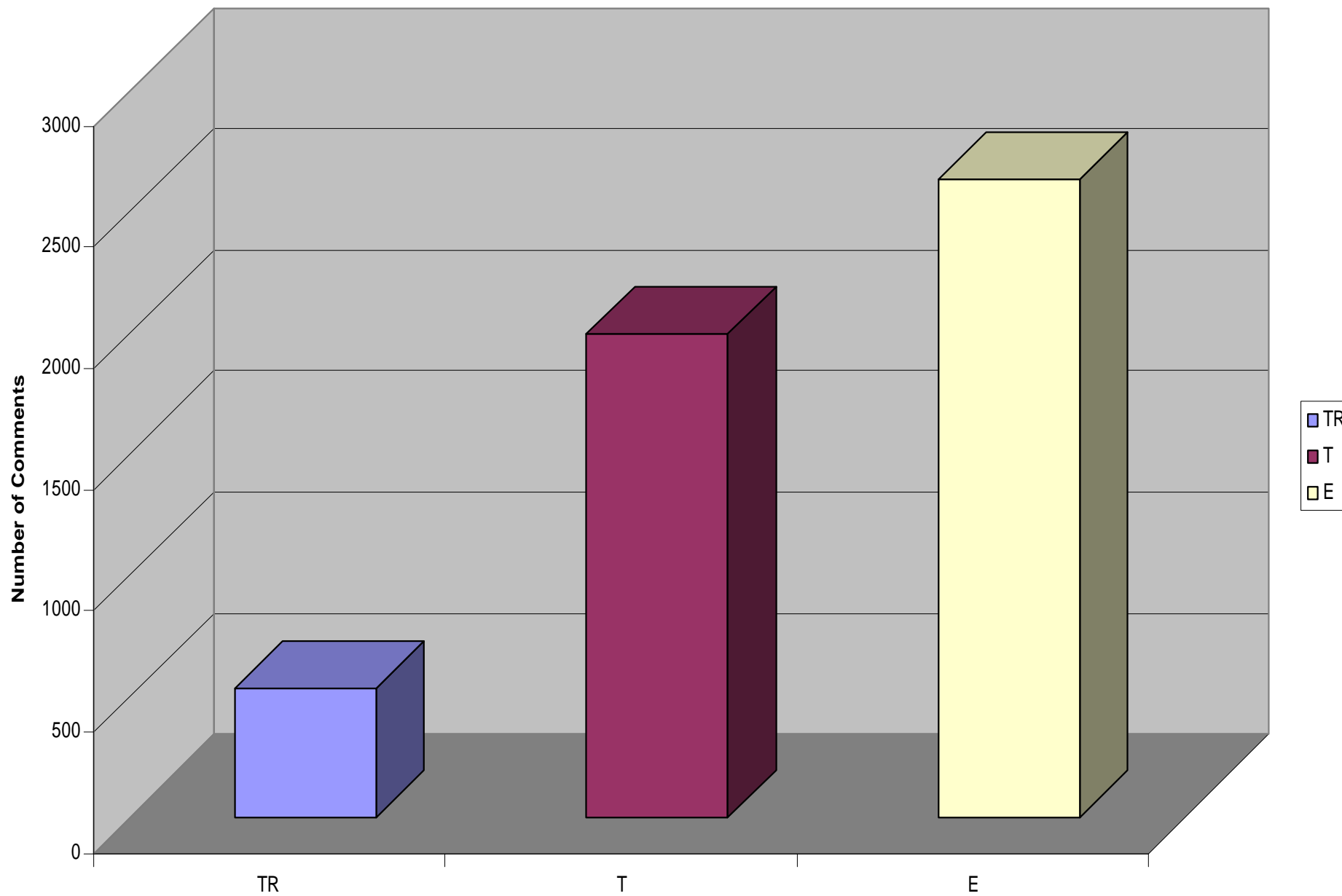
Cummulative Comments D1.2 through D2.0
