Maintenance Request #1246

This new maintenance request was discussed and there was no objection changing the status of the Maintenance Request to "Ready for Ballot".

Maintenance Request #1247

This new maintenance request was discussed and the submitter indicated that his preferred resolution is to delete the state transition. The Chair requested that Mr. Marris resubmit the Maintenance Request with the preferred resolution expressly stated. This Maintenance Request will be considered again at the Maintenance meeting in November.

Maintenance Request #1248

This new maintenance request was discussed. It was noted that the clause title pertaining to the requested revision should change from "Variables" to "When generated". The Chair requested that Mr. Marris resubmit the Maintenance Request with the correct title. It was noted that this comment addresses content of IEEE 802.3bj, which should enter Sponsor ballot soon. Mr. Marris was requested to submit a comment against the Sponsor ballot of IEEE 802.3bj related to this proposed change. This Maintenance Request will be considered again at the Maintenance meeting in November.

IEEE 802 contribution to ITU-R WP1A

Question ITU-R 236/1 includes a question in relation to the impact on radiocommunication systems of wireless and wired data transmission technologies used for the support of power grid management systems. A response was drafted including excerpted baseline information from the IEEE 802.3 scope statement. Mr. Law will coordinate our response with the input provided by the wireless experts and will provide text for review at the next Maintenance meeting in November.

CEN-CENELEC-ETSI Smart Grid Coordination Group

Mr. Law informally reviewed a matrix of applicable communication technologies to smart grid networks prepared by CENELEC. IEEE 802.3/1 was identified as applicable to six types of communication technologies in the table in clause 10.6.1. It was proposed that IEEE 802.3 be a separate line item from IEEE 802.1 in this table and should be applicable to all fifteen types of communication technologies. It was agreed that intensive review of the document would be required for complete accuracy, but our review should be limited to IEEE 802.3-related issues. Discussion will continue at the next Maintenance meeting in November.
