ADMINISTRATIVE MATTERS

Mr. Robert Grow, Chair of 802.3 CSMA/CD Working Group called the meeting to order at 1:08PM. Mr. Grow introduced Mr. David Law, Vice Chair of 802.3, and Mr. Steve Carlson, Secretary of 802.3, and Task Force Chair of 802.3af. Mr. Howard Frazier, Chair of the 802.3ah Task Force was also introduced, along with Brad Booth, Chair of the 10GBASE-T Study Group, and Dan Dove, Chair of the 802.3ak Task Force.

Mr. Grow then had the attendees stand and introduce themselves to the group. Mr. Grow reminded the group that there is an ANSI policy regarding affiliation.

IEEE and 802 Brand Identification

Karen McCabe from IEEE Sr. Marketing Manager from SA discussed brand ID.

Bruce Tolley – Cisco – Are you saying that the Standard is the IP of the IEEE SA? Mr. Grow explained that the copyright is assigned to the IEEE SA. Bruce – I don't understand what you want from us...when do we use the TM?

David Law – 3Com – IEEE kite logo---anyone can download the logo from the Website, if a 3rd party used the logo, it implies that IEEE agrees with the content of the site.

Geoff Thompson – Nortel – Brand protection is a cost center, not a profit center. Where is the money going to come from to do a good job? Karen Rupp – financial officer said that this is being discussed.

Brand protection is for whose benefit? For 802, or for IEEE? Karen Rupp, we don't have the answers.

Pat Thaler – Agilent – 15 year history of not doing this---how are we going to make this happen? Conformance claims for things that are not standards is a reasonable area, but once it is a standard, can IEEE really take the project on?

Terry Cobb- Avaya – What is trademarked? 802 is a registered trademark.

Bruce Tolley – Is IEEE going to enforce this?

Tom Dineen – We are a non-profit forum where professionals get together to develop the standards, why do we need to do this now?

Patent Policy

Mr. Grow read the IEEE Patent Policy <0703_Open_report.pdf> Mr. Grow asked if anyone had any IP, and no one came forth. Mr. Grow reminded the group not to discuss territory, market share, price, ongoing litigation, threatened litigation, etc.
