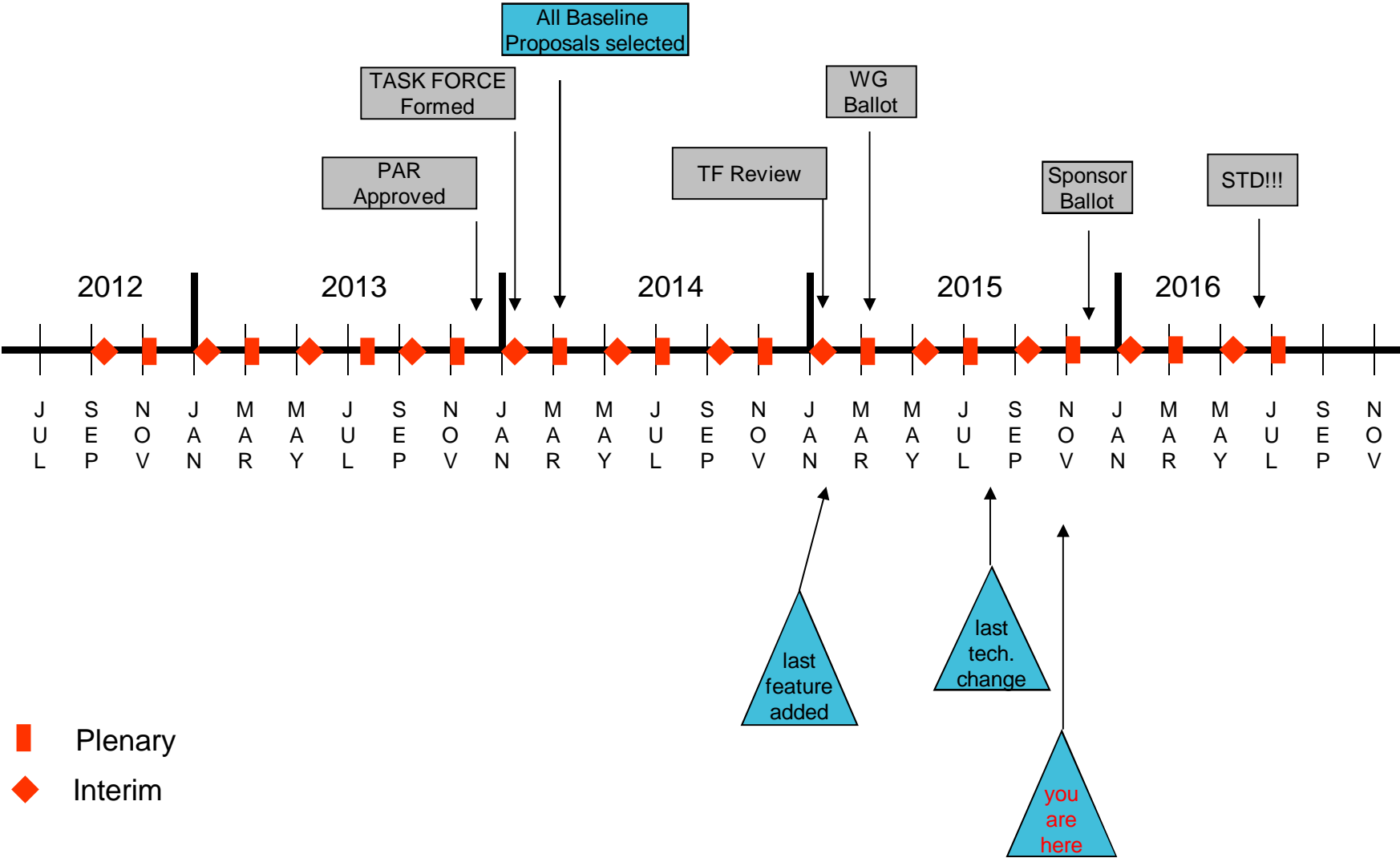

Activities since July 2015 plenary

- Met during the September 2015 interim meeting series
- Major items discussed, decisions made and actions:
 - ❑ Motion#1 on “Accept the 802.3br July 2015 Waikoloa meeting minutes
 - ❑ WG IEEE 802.3 WG ballot D2.2 (2nd initial ballot) was approved with 51 comments
 - Created a disposition of comments on Draft D2.2
 - Motion#2 on „The IEEE P802.3br Interspersing Express Traffic Task Force accept the comment resolutions to D2.2 as detailed in p8023br-2-2-comment-disposition.pdf created at the September 2015 Task Force meeting and charter the editor to produce working group draft D2.3 for a 30-day recirculation ballot.“ unanimously approved.
 - ❑ Motion#3: The IEEE P802.3br Interspersing Express Traffic Task Force adopts the new timeline.
 - ❑ Motion#4: The IEEE P802.3br Interspersing Express Traffic Task Force requests the Task Force Chair to work with the WG Executive Committee to schedule and announce an interim meeting in between 2015-12-03 and 2015-12-12.
