European Travel Information and Authorization Applicability (ETIAS)

ETIAS is required for travelers from visa-exempt countries who intend to enter any of the 29 Schengen countries, including Germany.

Application Process: The application is completed online and involves providing personal information, travel details, and answering security-related questions. The process is designed to be straightforward and should take only a few minutes.

Fee: There is a fee of €7 for the application, which is waived for travelers under 18 and over 70 years old.

Validity: Once approved, the ETIAS authorization is valid for three years or until your passport expires, whichever comes first. It allows for multiple short-term stays of up to 90 days within any 180-day period.
