2. John presented and updated the list of current vehicles (drafts) used for implementing maintenance items.
 - a. 802.1Q-2014 was approved Nov 3rd, 2014
 - TG Chair will check, or request MR originators to check, that their items have been resolved.
 - b. 802.1Q-2014/Cor1 PAR was approved on Feb 16th, 2015
 - D0.1 (2nd draft) available, not balloted yet
 - c. 802.1AX-Rev/D4.54 has been approved on Dec 10th, 2014 and published on Dec 24th, 2014
 - Maintenance entries need to be checked
 - d. 802.1AB-Cor 2 was approved on Feb 16th, 2015
 - e. 802.1AB-Rev PAR approved on Dec 10th, 2014
 - No Initial draft yet
 - f. 802.1AC/D2.0 draft not yet available
 - g. 802.1AS-Cor2 PAR approved on Dec 10th, 2014.
 - WG d0.1 ballot closed, 2nd draft available, plan to go to Sponsor
 - h. 802.1AS-Rev PAR approved Feb 16th, 2015
 - Not balloted yet
 - Need to withdraw 802.1ASbt PAR now
3. We reviewed the updated proposed comment responses to comments received from SC6 on
 - a. the 60-day pre-ballot of IEEE Std 802.
 - b. the FDIS ballots of 802.1AEbn and 802.1AEbw.

5. We reviewed the two new maintenance items which have been received:
 - a. 0158: SRP: Proposed changes to allow use of VLAN 1
