 - g. 802.1Xck not yet issued for ballot
 - h. 802.1Qcc/D0.5 has been out for TG ballot.
 - Comment resolution at this meeting in TSN.
 - i. 802.1BA-Cor1 draft is available
 - PAR is on Jan 26th 2016 NesCom agenda
 - j. Std 802d amendment PAR for URN Namespace was approved Dec 5th, 2015
- 3. Janos Farkas performed comment resolution on 802.1AX-2014-Cor1/D0.3 following working group ballot.
- 4. We reviewed and updated the proposed comment responses to comments received from SC6 on the FDIS ballot of 802.1Q-2014.
