The chair, John Messenger, introduced the agenda, showed the patent policy slides and made the call for patents. There were no responses.

- John presented the list of current vehicles (drafts) used for implementing maintenance items, and the current numerical status of maintenance items in the database. Details in the Maintenance Session Slides.
- 2. John reported that the 802.1Q-Rev sponsor ballot has not opened due to a delay in Mandatory Editorial Coordination.
- 3. The new maintenance items were discussed and progressed:
 - a. 0195: 802.1Qch typo in figure Q-3: received;
 - b. 0196: 802.1X MKA pending PN exhaustion: solution included in 802.1Xck/D1.1, balloting.
- 4. Existing maintenance items were reviewed.
 - a. 0183: addressed via a comment on the 802.1Q-Rev sponsor ballot.
- 5. John presented the editor's draft of P802.1AC-2016-Cor-1, prepared in response to the liaison from IETF on the LLC Encapsulation Ethertype. The PAR has been granted and it is proposed to send the draft to Working Group ballot.
- 6. Comment resolution was performed on P802.1Q-Rev/D2.0. This began in the Maintenance Task Group and continued in TSN, due to lack of time in Maintenance.
- 7. We considered the proposals to withdraw P802.1D and ISO/IEC 15802-1 (old MAC Service Specification) and 15802-3 (old MAC Bridges specification).
- 8. Liaisons:
 - a. We reviewed the draft response to the IETF LLC Long Frames Ethertype liaison.
 Unfortunately this liaison was omitted from the approvals in the July plenary, so it will be reconsidered at the plenary this week.
 - b. Received liaison from MEF on MEF 4.
- 9. We reviewed the proposed comment responses to the 802.1AEcg 60-day ballot in ISO SC6.
- 10. We reviewed the status of standards in the PSDO process.
