



Call for Comments IEEE P802.16Rev3/D1

Deadline: 14 September 2011 AOE

On 17 May 2011, the IEEE-SA Standards Board approved a Project Authorization Request (PAR) <<http://ieee802.org/16/pars/P802.16Rev3.pdf>>, known within the IEEE 802.16 Working Group as P802.16Rev3, authorizing the development of a new revision to IEEE Standard 802.16. This project will develop a draft revision of IEEE Std 802.16-2009, incorporating three amendments (P802.16h, P802.16j, and P802.16m) but excluding the WirelessMAN-Advanced radio interface, which is to be moved to a standalone standard (IEEE Std 802.16.1) that will be developed separately and simultaneously.

An initial draft of the revision has been developed by a professional editor on the basis of the PAR. This draft, P802.16Rev3/D1, is posted at <http://ieee802.org/16/private/drafts/maint/P80216Rev3_D1.zip>.

The 802.16 Working Group has assigned the development of the P802.16Rev3 project to the Maintenance Task Group <<http://ieee802.org/16/maint>>. In preparation for the Working Group's upcoming Session #75 <<http://ieee802.org/16/meetings/mtg75>> in Bangkok, Thailand, comments on P802.16Rev3/D1 are invited.

To participate, prepare comments in Commentary <<http://dot16.org/Commentary>> format. Comments must be written with respect to approved draft **P802.16Rev3/D1** rather than to IEEE Standard 802.16. Comments must be submitted as files named according to the format *Rev3_NameFamily_NameGiven.cmtb*, where "NameFamily" and "NameGiven" are the family and given names of the submitter. **Comments** must be uploaded to <<http://upload.wirelessman.org>> using the "**Maint**" upload directory.

Accompanying document contributions may be submitted, if necessary, following the instructions at <<http://WirelessMAN.org/submit.html>>. Contribution document naming must follow the format C802.16Rev3-11/XXXX. **Contributions** must be uploaded to <<http://upload.wirelessman.org>> using the "**Rev3**" upload directory.

Contributions and comments will be considered non-confidential and will be posted for public access on the IEEE 802.16 Web Site <<http://WirelessMAN.org>>. Reply comments will be invited, with a deadline of 19 September (noon local time in Bangkok).

Submit your contribution and comments by the **deadline of 14 September 2011**.
