The draft letter was discussed and modified in order to complete it and in order to not sound apologetic about the issue of having to renumber sections, tables and figures in P802.16-Rev2.

14:25 Phil Barber calls the question. 8 in favor 4 opposed. The question is called.

Reissued the letter as IEEE 802.16maint-07/025 and uploaded it to the Maintenance directory on the local server.

Jim Carlo presented to the group the IEEE-SA Standards Board operations manual http://standards.ieee.org/guides/opman/sb-om.pdf, specifically section 9.2 on Revisions, to review with the task group what Revision project means.

After some discussion three options were developed, as to how to proceed on the Rev2 project between sessions #50 and #51:

- 1. Incorporate editorial comment resolutions and 16g into Rev2, generate Rev2/D0d and issue a call for editorial comments, which are to be resolved at Session #51.
- 2. Incorporate editorial comment resolutions and 16g into Rev2, generate Rev2/D1 and initiate LB#26. Resolve LB comments at Session #51.
- 3. Incorporate editorial comment resolutions in to Rev2, and initiate LB #26. Resolve LB comments at Session #51.

After additional discussion option #3 was eliminated by consensus. Certain members did not want option #2, due to lack of time for review of the large document between the two sessions. As a compromise, a proposal was put forward to make a motion requesting that the first recirculation of the letter ballot be a minimum of 30 days and that the entire draft (Rev2/D2) would be open for review.
