# Process



- Each section will be dealt with in turn
  - Order: Clause 0, Intro, OAM, Bridging, Fairness, Protection, PHY, MAC
- Editor will present summary of resolutions by ad-hoc
  - No more than **<u>20 minutes per report</u>**, including questions
- Comments punted to WG will then be debated and resolved
  - Any WG member can also request that any comment be broken out of the bucket and debated by WG as a whole
  - Chair will limit debate to <u>5 minutes each</u> in the interests of progress
- Single motion per section to accept ad-hoc group's resolutions to resolved comments as a bucket
  - Ad-hocs to resolve issues raised by comments authorized at this time (by acceptance of comments)
- Authorize creation and balloting of D2.1 based on instructions





# Draft Creation/Posting Schedule (Subject to revision based on workload)

- *10 days* for Editors to create D2.1 from comment resolutions
  Draft clauses sent to Chief Editor by January 28th
- 3 days to clean up, review and assemble D2.1
  - Also, update MIB to reflect changes in remainder of the draft
  - Draft 2.1 posted on January 31
- Comment period runs from February 1 to March 2
  30 days to review draft and post comments
- Comment database posted for review and proposed resolutions by March 4th
  - 6 days to review comments prior to meeting
- Plenary meeting starts March 10th




# Clause 0 Comments

  - (#4, max delay through MAC/PHY/RS etc.)
