- Current document material format in 802.20:
  - We do not have a formal 802.20 template for contribution files (e.g., ppt and doc).
  - All submission files are converted to a “pdf” format.
  - File name is edited like C802.20-03-29.
- Learn from other Working Groups
  - ppt & doc are used
    - Working Groups 802.11, 15, 18, 19
  - pdf is used
    - Working Groups 802.1, 3, 16, 17
- What will be our choice in 802.20WG?

# Pros & Cons

- **DOC & PPT files**
  - User friendly, not author friendly.
  - Animation can be used.
  - Easily reused by other users.
  - Can be modified.
- **PDF files**
  - Not easily reused by other users.
  - Author friendly, not user friendly
  - Printing may have problems.
  - Protected from modification.

# Motion

- To affirm DOC & PPT & PDF file format to be an IEEE802.20 formal template. If PDF is used, an original format must use white color as a background for a printing purpose.
- To affirm any text proposed for inclusion in a draft standard to be available in DOC.
- To empower Gang Wu to create template formats, DOC and PPT, for IEEE802.20.

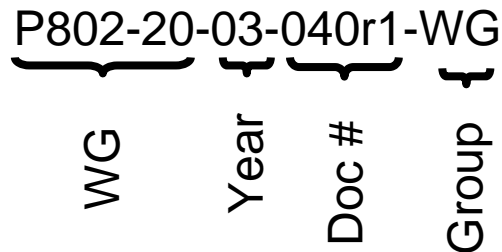

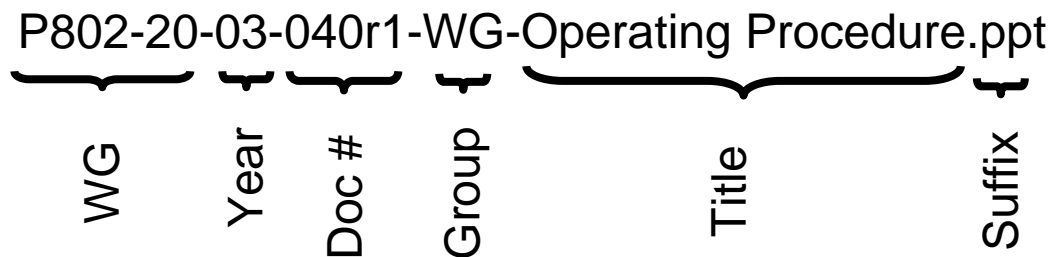
# New Naming Scheme

Document Number (in header of doc)



- 1. No category (e.g., contribution, documents, permanent documents)
- 2. Explicitly two digit year, three digit doc# revision #, Group (e.g., WG, TG, ...)
