Comment resolution discussion for all Technical comments to date.

Preliminaries:

Patent statement was presented with no response from the participants.

Presentation/Discussion:

- Dan showed his new supporting document, smith_3bcb_01_20161027.ppt, that was meant to remove all ambiguity of references to test patterns, as an In Principle solution for comment #267. During the discussion, it was found that Clause 120.5.10 in 802.3bs (the source), has been moved to Clause 120.5.11, and has changed significantly. This will require work from Dan and Anthony Calbone to create new wording for the solution that will be acceptable to the commenter. When that is sorted, Dan will post this document as a new supporting document on the Public, Ad Hoc page, and eventually on the TF Meeting page for Nov Plenary week.
- Yong went through document, Kim_3cb_02_Oct27-2016_CL127-2-6_Proposed_CR.pdf, updated and finalized and posted on the Ad Hoc public page. Some changes had to be added to further the completion of the receive path, not originally in the comment. Yong's document has been sent to 2 commenters for approval. The work is proceeding, in this area, on the draft.
- Larry showed his highlighted PDF of the "double-documentation" research he did on Annexes
 128A and 130A. He found many more items that needed correction. Dan will put these "new"
 items that are not part of existing comments (which could be added as In Principle), in to a
 bucket document to be issued as part of the editorial work on Draft 2.0 that will be forwarded
 as Draft 2.1 during the Working Group Ballot recirculation.
- The Chief Editor has completed many of the changes to date and accomplished changes with regard to Framemaker graphics issues. An intermediate draft should be posted soon on the Private page for review.
