Preliminaries:

Patent statement was presented with no response from the participants.

Presentation/Discussion:

- Status was given by Peter on his latest contributions to 128.7 that have been sent to Yong and included in the newest working draft.
- Yong has incorporated comments from 'major contributors'. If anyone wants to see
 intermediate PDFs, Yong will provide. He will be including all of William's contributions by the
 end of this week (May 6/7/8). Any stable drawings and cross references will be included. There
 should be a fresh PDF of the draft by the May 24/25 Interim meeting.
- Dan will issue another broadcast to 802.3 stating the upcoming comment deadline we have received no comments, except from the Task Force contributors. Is 'no news, good news'?
- Yong briefly explored the TBDs in the current draft with suggestions for proceeding. He asked
 everyone to go through the TDBs in the clauses and annexes. If you encounter a '??' mark and
 understand the number to be accurate, please add a comment note to that effect, allowing us
 to move on.
- June 27th meeting close, there should be 'no' technical holes in the parameters. Otherwise, we will not meeting the July Interim deadline to have the draft ready for Working Group Ballot. Our Working Group comments can 'tweak' those, but we need to have all values in place. No open topics out of the June 27th interim in Mountain View.
 - If you haven't responded to Rita about the attending the meeting on June 27th, please contact her.
- At the July Plenary in San Diego, we may want to meet Monday morning, Tuesday, Wednesday, and Thursday morning, if we need more time to finalize the draft before Working Group Ballot release. But... we will discuss need for those days at the May 24/25 meeting in Whistler, when we see how much is accomplished by then. We expect the technical details of the draft to have settled by then, reducing the workload at the July Plenary.
