

Guidelines for IEEE-SA Meetings

 - Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.
 - Don't discuss the status or substance of ongoing or threatened litigation.
 - Don't be silent if inappropriate topics are discussed ... do formally object.


Participants in the IEEE-SA "individual process" shall act independently of others, including employers

- The <u>IEEE-SA Standards Board Bylaws</u> require that "participants in the IEEE standards development individual process shall act based on their qualifications and experience"
- This means participants:
 - Shall act & vote based on their personal & independent opinions derived from their expertise, knowledge, and qualifications
 - Shall not act or vote based on any obligation to or any direction from any other person or organization, including an employer or client, regardless of any external commitments, agreements, contracts, or orders
 - Shall not direct the actions or votes of other participants or retaliate against other participants for fulfilling their responsibility to act & vote based on their personal & independently developed opinions
- By participating in standards activities using the "individual process", you are deemed to accept these requirements; if you are unable to satisfy these requirements then you shall immediately cease any participation

IEEE-SA standards activities shall allow the fair & equitable consideration of all viewpoints

- The <u>IEEE-SA Standards Board Bylaws</u> (clause 5.2.1.3) specifies that "the standards development process shall not be dominated by any single interest category, individual, or organization"
 - This means no participant may exercise "authority, leadership, or influence by reason of superior leverage, strength, or representation to the exclusion of fair and equitable consideration of other viewpoints" or "to hinder the progress of the standards development activity"
- This rule applies equally to those participating in a standards development project and to that project's leadership group
- Any person who reasonably suspects that dominance is occurring in a standards development project is encouraged to bring the issue to the attention of the Standards Committee or the project's IEEE-SA Program Manager


Overview of IEEE 802.3 Standards Process (1/5)-Study Group Phase




Note: At "Check Point", either the activity is ended, or there may be various options that would allow reconsideration of the approval.


Overview of IEEE 802.3 Standards Process (2/5) – Task Force Comment Phase




Overview of IEEE 802.3 Standards Process (3/5) – Working Group Ballot Phase

The Study Group

- Normal function is to draft a complete Project Authorization Request (PAR) and Criteria for Standards Development (CSD, includes Five Criteria)
- Gain approval at the IEEE 802.3 WG, IEEE 802 EC, IEEE-SA NesCom and IEEE-SA Standards Board
- SG only exists for 6 months
 - Extensions can be requested
 - Voted on by IEEE 802.3
 - Ratified by IEEE 802 EC
- Development of Objectives helps set the goals for the Task Force
- Consensus required to move forward
- Not a goal choosing a solution.

Request for Formation of Study Group (per July 2019 Plenary Motion, amended Sep/Oct 2019)

 Move that the IEEE 802.3 Working Group request the formation of a Study Group to develop the Project Authorization Request (PAR) and Criteria for Standards Development (CSD) responses for Multi Gigabit Automotive Optical PHYs.

Status Update

- Proposed rules changes, per 6 May rules ad hoc (might be updated verbally)
 - Suspend LMSC Operations Manual procedures in exceptional circumstances with a 2/3 vote (early close ballot) of the Executive Committee
 - There was significant opposition from EC voting members to granting power to the Chair to suspend the rules without objection.
 - · Rules change ballot to progress in parallel with March PAR review
- Working toward keeping March PARs on June NesCom agenda
 - Enabling rules changes (LMSC P&P and LMSC OM changes in process)
 - Process for March PARs defined (assumes rules changes will be approved)
- Process for us

Version 3.8

- The LMSC Chair has requested the start of review/comment between WGs on March PAR/CSD submissions.
 - 11 May 802.3 ad hoc for comments on 802.15.7a and 802.1ASdm submissions
 - 15 May OMEGA interim SG teleconference to respond to comments on our PAR/CSD
- 21 May 802.3 WG to approve our PAR, CSD and Objectives
- 28 May LMSC Executive Committee meeting to approve PARs
- 2 June NesCom virtual meeting, 4 June SASB virtual meeting for PAR approval

SG process

- Study Group actions:
 - 802.3 Operating Rules have been suspended to reduce notice requirements for SG meetings
 - A SG cannot conduct "letter ballots" (electronic votes) per LMSC **Operations Manual**
 - Anyone attending SG meetings (including interim teleconference) can vote
 - SG motions:
 - Can pass via unanimous consent
 - If not unanimous consent, a roll call vote is required
 - To facilitate taking a roll call vote, advanced SG meeting registration is required
 - Register at least 24 hours in advance
 - Late registration allowed but think how much time of others you waste registering late

Comment Resolution and motions

- Deadline for comments from other WGs is 1 hr. prior to SG interim meeting (this meeting)
- Changes to PAR, CSD (or Objectives) will require approval by motion
