

#### **Guidelines for IEEE-SA Meetings**

- All IEEE-SA standards meetings shall be conducted in compliance with all applicable laws, including antitrust and competition laws.
  - Don't discuss the interpretation, validity, or essentiality of patents/patent claims.
  - Don't discuss specific license rates, terms, or conditions.
    - Relative costs of different technical approaches that include relative costs of patent licensing terms may be discussed in standards development meetings.
      - Technical considerations remain the primary focus
  - Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.
  - Don't discuss the status or substance of ongoing or threatened litigation.
  - Don't be silent if inappropriate topics are discussed ... do formally object.


## Participants in the IEEE-SA "individual process" shall act independently of others, including employers

- The <u>IEEE-SA Standards Board Bylaws</u> require that "participants in the IEEE standards development individual process shall act based on their qualifications and experience"
- This means participants:
  - Shall act & vote based on their personal & independent opinions derived from their expertise, knowledge, and qualifications
  - Shall not act or vote based on any obligation to or any direction from any other person or organization, including an employer or client, regardless of any external commitments, agreements, contracts, or orders
  - Shall not direct the actions or votes of other participants or retaliate against other participants for fulfilling their responsibility to act & vote based on their personal & independently developed opinions
- By participating in standards activities using the "individual process", you are deemed to accept these requirements; if you are unable to satisfy these requirements then you shall immediately cease any participation

## IEEE-SA standards activities shall allow the fair & equitable consideration of all viewpoints


- The <u>IEEE-SA Standards Board Bylaws</u> (clause 5.2.1.3) specifies that "the standards development process shall not be dominated by any single interest category, individual, or organization"
  - This means no participant may exercise "authority, leadership, or influence by reason of superior leverage, strength, or representation to the exclusion of fair and equitable consideration of other viewpoints" or "to hinder the progress of the standards development activity"
- This rule applies equally to those participating in a standards development project and to that project's leadership group
- Any person who reasonably suspects that dominance is occurring in a standards development project is encouraged to bring the issue to the attention of the Standards Committee or the project's IEEE-SA Program Manager

#### Overview of IEEE 802.3 Standards Process (1/5)-Study Group Phase




Note: At "Check Point", either the activity is ended, or there may be various options that would allow reconsideration of the approval.


## Overview of IEEE 802.3 Standards Process (2/5) – Task Force Comment Phase




# Overview of IEEE 802.3 Standards Process (3/5) – Working Group Ballot Phase

## Overview of IEEE 802.3 Standards Process (5/5) – Final Approvals / Standard Release



### The Study Group

- Normal function is to draft a complete Project Authorization Request (PAR) and Criteria for Standards Development (CSD, includes Five Criteria)
- Gain approval at the IEEE 802.3 WG, IEEE 802 EC, IEEE-SA NesCom and IEEE-SA Standards Board
- SG only exists for 6 months
  - Extensions can be requested
  - Voted on by IEEE 802.3
  - Ratified by IEEE 802 EC
- Development of Objectives helps set the goals for the Task Force
- Consensus required to move forward
- Not a goal choosing a solution.

#### Request for Formation of Study Group (per July 2019 Plenary Motion, amended Sep/Oct 2019)

 Move that the IEEE 802.3 Working Group request the formation of a Study Group to develop the Project Authorization Request (PAR) and Criteria for Standards Development (CSD) responses for Multi Gigabit Automotive Optical PHYs.

### Status Update (since 14 April)

- EC actions on 21 April proposed rules changes (to be updated)
  - Grant LMSC Chair ability to suspend LMSC Operations Manual procedures in exceptional circumstances?
    - · Without objections of an EC member?
    - By motion and vote of EC?
    - · Can't start EC rules change ballot until 13 May
  - Any action possible on March PAR/CSD submissions?
    - There is support (no stated opposition) for keeping June NesCom submissions on the NesCom agenda
    - Requires enabling rules change: LMSC Chair action to start a review process, EC agreement to process, EC PAR/CSD approval prior to NesCom meeting
    - · NesCom meeting has not yet been scheduled, might be earlier than original SASB series schedule
    - Time is running out to start a review process to run in parallel with rules change
  - Failure to keep PAR on June NesCom agenda probably slips approval to September
  - Failure to get a rules change risks slip past September

### SG process

- Study Group actions:
  - 802.3 Operating Rules have been suspended to reduce notice requirements for SG meetings
  - A SG cannot conduct "letter ballots" (electronic votes) per LMSC **Operations Manual**
  - Anyone attending SG meetings (including teleconference) can vote
  - SG motions:
    - Can pass via unanimous consent
    - If not unanimous consent, a roll call vote is required
  - To facilitate taking a roll call vote, advanced SG meeting registration is required
    - Register at least 24 hours in advance
    - Late registration allowed but think how much time of others you waste registering late
