- 1:03 Meeting called to order. Meeting started by the Ad Hoc Chair, Chad Jones.

Plug and Play support

Not all cabling can support 2A, there are significant subset of power classes that operate below 0.75A

Users might sacrifice plug and play for smaller diameter conductors

Need to make this clear that this is ONLY about SPE cabling (not 4P PoE)

Point to the appropriate TIA and ISO docs

TSB 184A, TR29125

Do we want to specify how you do engineered solutions in 802.3? Consensus was no.

How do we talk about 2A supplies on 0.75A cables?

802.3 is not a safety document, this will be a delicate topic to address

Do we need to consider the permanent link and channel separately?

The plan is to formalize some text around this discussion points and continue the conversation in the next meeting.
