**5.1 Approximate number of people expected to be actively involved in the development of this project:** 50

**5.2.a. Scope of the complete standard:** This standard defines Ethernet local area, access and metropolitan area networks. Ethernet is specified at

selected speeds of operation; and uses a common media access control (MAC) specification and management information base (MIB). The Carrier Sense Multiple Access with Collision Detection (CSMA/CD) MAC protocol specifies shared medium (half duplex) operation, as well as full duplex operation. Speed specific Media Independent Interfaces (MIIs) provide an architectural and optional implementation interface to selected Physical Layer entities (PHY). The Physical Layer encodes frames for transmission and decodes received frames with the modulation specified for the speed of operation, transmission medium and supported link length. Other specified capabilities include: control and management protocols, and the provision of power over selected twisted pair PHY types.

**5.2.b. Scope of the project:** The scope of this project is to specify additions to and appropriate modifications of IEEE Std 802.3 to add a point-to-point 1 Gb/s Physical Layer (PHY) specifications and management parameters for operation over a single twisted pair copper

**5.4 Purpose:** This document will not include a purpose clause.

**5.5 Need for the Project:** Adoption of Ethernet into new market areas in automotive, industrial controls and automation, transportation (aircraft, railway and heavy trucks) has generated a need for a 1 Gb/s solution that will operate over a single twisted pair copper cable on a lower-performance channel as well as other applications, such as carbon footprint sensitive applications, that will benefit by a reduction in the number of wire pairs and magnetics. IEEE Std 802.3 does not currently support 1 Gb/s operation over fewer than four pairs of twisted copper cable.

**5.6 Stakeholders for the Standard:** Stakeholders identified to date includes but are not limited to: users and producers of systems and components for the automotive, industrial controls, transportation (aircraft and rail) industries.
