Draft 1.2 Comment Resolution

D1.2 received 36 comments. Two presentations are related to the comments. They were presented when resolving these comments.

802.3cp Protocol Implementation Conformance Statement (PICS) Yuanqiu Luo Futurewei

This presentation proposes PICS forms for Clauses 158, 159, 160. The PICS forms register "shall"s in the new PHYs. Related comments are #99, #102, #109. Members agreed to fill the PICS forms as proposed in this contribution.

Major Comments to D1.2 Yuanqiu Luo Futurewei

This presentation collects three groups of comments. Group A (Comments #110, #111) are to use more practical values for 10GBASE-BR40. Group B (Comments #80, #90, #91) propose to use 25GBASE-ER for 25GBASE-BR40. Group C (Comments #92, #93, #112, #113) propose to use 50GBASE-ER for 50GBASE-BR40. Members accepted the proposals in Groups B and C. The proposal in Group A was discussed, members would work during the break to improve them.

3-3:20pm Meeting break

Group A proposal was discussed again. Most numbers were adjusted to fit the loss range. Frank recorded the agreed numbers. This resolved Group A (Comments #110, #111).

Liaison to ITU

The ITU-T Q2/15 meeting in April has been cancelled. We intend to continue sharing our draft through informal channels.
