

  - Don't discuss the status or substance of ongoing or threatened litigation.
  - Don't be silent if inappropriate topics are discussed ... do formally object.


### Participants in the IEEE-SA "individual process"

  - Shall act & vote based on their personal & independent opinions derived from their expertise, knowledge, and qualifications
  - Shall not act or vote based on any obligation to or any direction from any other person or organization, including an employer or client, regardless of any external commitments, agreements, contracts, or orders
  - Shall not direct the actions or votes of other participants or retaliate against other participants for fulfilling their responsibility to act & vote based on their personal & independently developed opinions
- By participating in standards activities using the "individual process", you are deemed to accept these requirements; if you are unable to satisfy these requirements then you shall immediately cease any participation

## IEEE-SA standards activities shall allow the fair & equitable consideration of all viewpoints


- The <u>IEEE-SA Standards Board Bylaws</u> (clause 5.2.1.3) specifies that "the standards development process shall not be dominated by any single interest category, individual, or organization"
  - This means no participant may exercise "authority, leadership, or influence by reason of superior leverage, strength, or representation to the exclusion of fair and equitable consideration of other viewpoints" or "to hinder the progress of the standards development activity"
- This rule applies equally to those participating in a standards development project and to that project's leadership group
- Any person who reasonably suspects that dominance is occurring in a standards development project is encouraged to bring the issue to the attention of the Standards Committee or the project's IEEE-SA Program Manager

#### Overview of IEEE 802.3 Standards Process (1/5)-Study Group Phase




## Overview of IEEE 802.3 Standards Process (2/5) – Task Force Comment Phase




## Overview of IEEE 802.3 Standards Process (3/5) – Working Group Ballot Phase

# IEEE P802.3cp Bidi optical access PHYs Objectives

- Support full-duplex operation only
- Support bidirectional transmission over a single strand of single mode fiber using a single wavelength in each direction
- Support MAC data rates of 10 Gb/s, 25 Gb/s, and 50 Gb/s
- Support distances of at least 10 km, at least 20 km, and at least 40 km
- Preserve the Ethernet frame format utilizing the Ethernet MAC
- Support a BER of better than or equal to 10<sup>-12</sup> at the MAC/PLS service interface (or the frame loss ratio equivalent)
- Support optional Energy-Efficient Ethernet operation
- Support silent start\* operation to prevent bidirectional PHYs interfering with P2MP networks
- \* Silent start means that the upstream-facing PHY does not transmit unless a valid downstream signal is received. This prevents the bidirectional PHY from jamming transmission on the P2MP network in cases of unintentional connection
