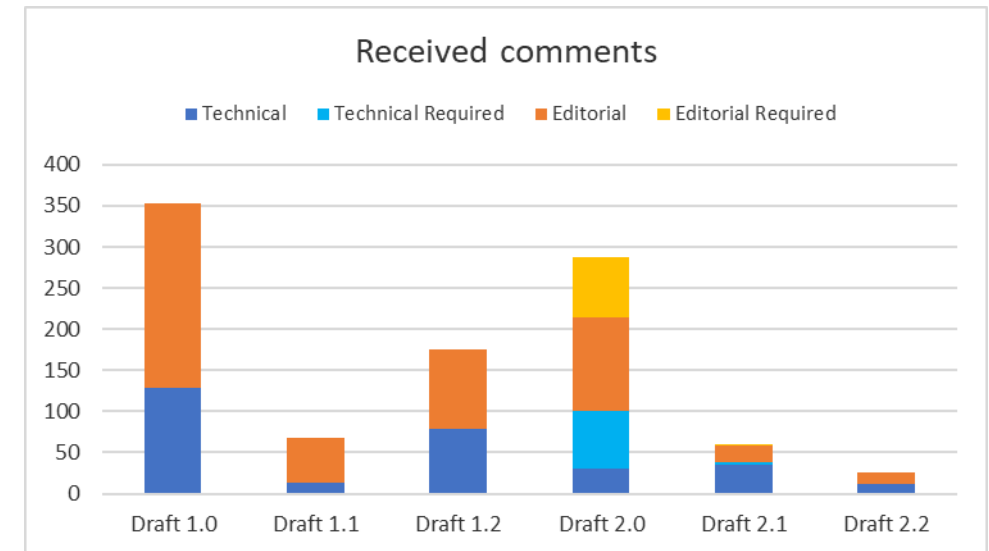

- The number of comments is decreasing (59 to 25)
- Many of the comments received may be considered “out-of-scope”, but some of them deserve to be discussed
- No required comments (technical or editorial) have been received
- A single comment requires a potentially substantial change (Comment #5)



Comment Resolution Roadmap

- Due to the number of comments, the editor's proposal is to review the comments received one by one in page and line order, regardless of other considerations.
- Comment #5 can be considered as substantial in the editor's opinion
 - Comment #5 is about the simplification of the Stressed receiver conformance test setup
- Other comments point out bad implementation of D2.1 comment resolution (i.e., typos, misunderstanding).
- The editor propose to generate a D2.3 and proceed with a third WG recirculation before going to Standard Association ballot.
- The 3rd WG recirculation of D2.3 starts 14 August and ends 28 August
- Comment Resolution during September 802.3 Interim meeting (6-7 September)
