# Tuesday, 9 June 2020, 12:00 (noon) UTC

The meeting was called to order at approximately 12:02 UTC Tuesday 9th June 2020 Chaired by David Law, IEEE 802.3 Chair.

Mr. Law appointed Bob Grow as Recording Secretary excect during the IEEE P802.3cz Task Force Chair confirmation during which he served as the Recording Secretary. Mr. Law explained that the IEEE 802.3 rules state that a Task Force Chair is appointed by the Working Group Chair and confirmed by the Task Force. Mr. Grow again reminded attendees that the new slide set included some slides not used during Task Force meetings. Mr. Grow offered to read through the slide set if requested – no one requested he do so. He did though review highlights of the slides.

Mr. Grow issued the call for essential patent claims. No one responded to the call.

Mr. Grow highlighted the progression from Study Group to Task Force and that our primary function now was to create a technically complete draft based on our approved Objectives.

Mr. Grow reviewed a possible timeline for the P802.3cz project. With no motion to adopt the timeline, it was left for people to review outside the meeting.

Mr. Rick Pimpinella had requested to present *Multimode Fiber Connector for Automotive Applications*. The presentation describes a possible connector based on an existing connector used of MOST automotive networks. A number of questions were asked about the presentation and Mr. Pimpinella provided answers.

Mr. Grow reviewed future meetings and reminded attendees that the Montreal venue and in-person meetings were cancelled because of the COVID-19 pandemic and related travel restrictions. He also noted that the IEEE 802 Executive Committee was still discussing whether a virtual plenary session would be held. Mr. Grow received no additional feedback on his plan to generally call Task Force interim teleconferences every second week.
