9 December 2025 Electronic Teleconference Meeting

Meeting called to order at 10:30 am (all times ET) by John D'Ambrosia, IEEE P802.3dj Task Force Chair.

The chair reminded participants to declare their affiliation in the online meeting tool. Failure to do so would result in expulsion from the meeting.

The chair asked if there were any modifications to the agenda (See slide #3). There were no objections to the approval of the agenda, and it was considered approved by unanimous consent.

Chair asked if there were any corrections or modifications to the November 2025 plenary minutes. (see: https://www.ieee802.org/3/dj/public/25_11/minutes_3dj_2511_unapproved.pdf) Kent Lusted noted an error on the last page of the unapproved minutes with template text. Chair asked if there were any objections to approving the minutes with the template page removed. There were none, and the minutes were considered approved by unanimous consent.

The chair reviewed meeting decorum (See Slide #5 and 6). Chair reminded participants to follow the decorum rules. Chair reminded participants of compliance with the IEEE Code of Ethics required by all participants.

The chair asked if any clarification is needed on IEEE SA Policies. There was none.

Chair noted that the information regarding the IEEE SA Policies had been sent out via the Task Force reflector , and requested that individuals review the following IEEE SA policies prior to the interim meeting –

- IEEE SA Patent policy
- IEEE SA Copyright Policy
- IEEE SA Participation Policy and IEEE Code of Ethics

Chair asked if anyone needed to review the policies at that time – there were no requests to do so from in-person nor remote attendees.

Chair presented the third slide (See Slide #29) of the IEEE SA Patent Policy slides. Chair did call for Potentially Essential Patents, and no one came forward.

Chair presented the second slide (See Slide #34) of the IEEE SA Copyright Policy slides. Chair noted – “By participating in this activity, you agree to comply with the IEEE Code of Ethics, all applicable laws, and all IEEE policies and procedures including, but not limited to, the IEEE SA Copyright Policy.”

Chair reminded participants of the IEEE Code of Ethics and Conduct. (See slide #37) He noted “All participants in IEEE-SA activities are expected to adhere to the core principles underlying the IEEE Code of Ethics and IEEE Code of Conduct”.

Chair presented the second slide (See Slide #38) of the IEEE SA Participation Policy slides. Chair noted – “Participants in the IEEE-SA “individual process” shall act independently of others, including employers. By participating in standards activities using the “individual process”, you are deemed to accept these requirements; if you are unable to satisfy these requirements then you shall immediately cease any participation.”

Chair presented the third slide (See Slide #39) of the IEEE SA Participation Policy. Chair noted that IEEE-SA standards activities should allow the fair & equitable consideration of all viewpoints, and The IEEE-SA Standards Board Bylaws (clause 5.2.1.3) specifies that “the standards development process shall not be dominated by any single interest category, individual, or organization”

The chair reminded participants to declare their affiliation in the online meeting tool.

The chair noted that individuals should fill out IMAT information for attendance.

At 10:45 a.m., John D’Ambrosia passed the meeting chair responsibilities to Kent Lusted.

Mr. D’Ambrosia noted that the presentation had been updated to “b” to correct a typo on Page 11.

Mr. D’Ambrosia also asked the chair for his co-authors to also be able to speak during the presentation. The Chair approved Mr. D’Ambrosia’s request.
