- 1) Recommendation G.983.4 "A Broadband Optical Access System with increased service capability using Dynamic Bandwidth Assignment"
- 2) Recommendation G.983.5 "A Broadband Optical Access System with Enhanced Survivability"
- 3) Recommendation G.983.7 "Enhanced ONT management and control interface specification for DBA B-PON system"
- 4) Amendment 1 to Recommendation G.983.2 (maintenance revisions to G.983.2)
- 5) Amendment 2 to Recommendation G.983.2 (enhancements for Voice service, AAL2, MAC Bridged LAN, and WDM services)
- 6) Amendment 1 to Recommendation G.983.1 (addition of 622 Mbit/s symmetrical rate to G.983.1)
- 7) Recommendation G.993.1 "Very-high-speed Digital Subscriber Lines Foundation"

In addition, Q.2/15 is proceeding to study Gigabit rate optical access systems. The system requirements of several large access network operators have been compiled into the following document which is intended to provide direction for the development of new systems:

COM 15 – D.238 "High-Level Initial Operator Requirements for Gigabit-per-second Passive Optical Networks (GPONs)"
