Guidelines for IEEE-SA Meetings

 - Don't discuss the interpretation, validity, or essentiality of patents/patent claims.
 - Don't discuss specific license rates, terms, or conditions.
 - Relative costs of different technical approaches that include relative costs of patent licensing terms may be discussed in standards development meetings.
 - Technical considerations remain the primary focus
 - Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.
 - Don't discuss the status or substance of ongoing or threatened litigation.
 - Don't be silent if inappropriate topics are discussed ... do formally object.

Participation in any IEEE 802 meeting (Sponsor, Sponsor subgroup, Working Group, Working Group subgroup, etc.) is on an individual basis

- Participants in the IEEE standards development individual process shall act based on their qualifications and experience. (https://standards.ieee.org/develop/policies/bylaws/sb_bylaws.pdf section 5.2.1)
- IEEE 802 Working Group membership is by individual; "Working Group members shall participate in the consensus process in a manner consistent with their professional expert opinion as individuals, and not as organizational representatives". (subclause 4.2.1 "Establishment", of the IEEE 802 LMSC Working Group Policies and Procedures)
- Participants have an obligation to act and vote as an individual and not under the direction of any other individual or group. A Participant's obligation to act and vote as an individual applies in all cases, regardless of any external commitments, agreements, contracts, or orders.
- Participants shall not direct the actions or votes of any other member of an IEEE 802 Working Group or retaliate against any other member for their actions or votes within IEEE 802 Working Group meetings, see https://standards.ieee.org/develop/policies/bylaws/sb_bylaws.pdf section 5.2.1.3 and the IEEE 802 LMSC Working Group Policies and Procedures, subclause 3.4.1 "Chair", list item x.

- In 45.2.3.75, remove the sentence "Register 3.2313.15 shall be cleared when register 3.2317 is read."
- The rationale is that this requirement also stated in Table 45-243 and 45.2.3.74.1 where this bit is defined.
- There are actually three locations where this requirement is defined with associated PICS items (RM134, RM135, RM136).
- Sometimes 3.2313.15 is referred to as a "bit" and sometimes as a "register" (it is a bit) It seems more changes are required to remedy this issue.

- Updated request that addresses all of these issues has been received.

- Separate point-to-multipoint into its own standard within the IEEE 802.3 family, e.g., "IEEE Std 802.3.n Standard for Multiport Access Ethernet"

- The request does not propose specific revision text ("TBD").
- Mark as "Received" until proposed text is provided and a more sufficiently clear IEEE 802.3 procedure to move forward is provided.

- In Figure 2-1, use of the term "PHY" is inconsistent with the IEEE 802.3 definition
 - "PHY" is "Physical Layer entity" which is the portion of the Physical Layer between the MII and MDI (see 1.5 and 1.4.391)
- Change "PHY" to "Physical Layer"
- Note that the requests refers to Figure 2-2 which does not exist.
