# Voting at electronic meetings

- IEEE 802.3 Task Force meetings will be classified as "electronic" for the purpose of voting

There are two type of votes in the TF; votes on motions and votes in straw polls.

In face-to-face meetings where a TF is operating with membership rules for voting (see 3.3) only the TF members may make and vote on motions. In face-to-face meetings where membership rules are not in force all TF participants may make and vote on motions, subject only to the provision that they believe that they are qualified to vote on the matter before the TF. Electronic meetings that will consider motions shall be approved by the WG Chair prior to the meeting announcement. In such meetings only IEEE 802.3 Working Group members may make and vote on motions. If a motion is not approved by unanimous consent it shall be taken as a roll call vote.

In all cases, regardless of any membership rules that may or may not be in force, all participants who feel qualified may participate in a straw poll.

#### INSTRUCTIONS FOR THE WG CHAIR

The IEEE SA strongly recommends that at each WG meeting the chair or a designee:

  - Any responses that were given, specifically the patent claim(s)/patent application claim(s) and/or the holder of the patent claim(s)/patent application claim(s) that were identified (if any) and by whom.
- The WG Chair shall ensure that a request is made to any identified holders of potential essential patent claim(s) to complete and submit a Letter of Assurance.
- It is recommended that the WG Chair review the guidance in *IEEE SA Standards Board Operations Manual* 6.3.5 and in FAQs 14 and 15 on inclusion of potential Essential Patent Claims by incorporation or by reference.

Note: **WG** includes Working Groups, Task Groups, and other standards-developing committees with a PAR approved by the IEEE SA Standards Board.





#### PARTICIPANTS HAVE A DUTY TO INFORM THE IEEE

- Participants <u>shall</u> inform the IEEE (or cause the IEEE to be informed) of the identity of each holder of any potential Essential Patent Claims of which they are personally aware if the claims are owned or controlled by the participant or the entity the participant is from, employed by, or otherwise represents
- Participants <u>should</u> inform the IEEE (or cause the IEEE to be informed)
   of the identity of any other holders of potential Essential Patent Claims

### Early identification of holders of potential Essential Patent Claims is encouraged





#### **WAYS TO INFORM IEEE**

- Cause an LOA to be submitted to the IEEE SA (patcom@ieee.org); or
- Provide the chair of this group with the identity of the holder(s) of any and all such claims as soon as possible; or
- Speak up now and respond to this Call for Potentially Essential Patents

#### OTHER GUIDELINES FOR IEEE WORKING GROUP MEETINGS

      - •Technical considerations remain the primary focus.
  - Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.
  - Don't discuss the status or substance of ongoing or threatened litigation.
  - Don't be silent if inappropriate topics are discussed. Formally object to the discussion immediately.

  - Shall not act or vote based on any obligation to or any direction from any other person or organization, including an employer or client, regardless of any external commitments, agreements, contracts, or orders
  - Shall not direct the actions or votes of other participants or retaliate against other participants for fulfilling their responsibility to act & vote based on their personal & independently developed opinions
- By participating in standards activities using the "individual process", you
  are deemed to accept these requirements; if you are unable to satisfy
  these requirements then you shall immediately cease any participation

# IEEE-SA standards activities shall allow the fair & equitable consideration of all viewpoints

- The <u>IEEE-SA Standards Board Bylaws</u> (clause 5.2.1.3) specifies that "the standards development process shall not be dominated by any single interest category, individual, or organization"
  - This means no participant may exercise "authority, leadership, or influence by reason of superior leverage, strength, or representation to the exclusion of fair and equitable consideration of other viewpoints" or "to hinder the progress of the standards development activity"
- This rule applies equally to those participating in a standards development project and to that project's leadership group
- Any person who reasonably suspects that dominance is occurring in a standards development project is encouraged to bring the issue to the attention of the Standards Committee or the project's IEEE-SA Program Manager

In half duplex mode, if multiple stations attempt to transmit at the same time, it is possible for them to interfere with each other's transmissions, in spite of their attempts to avoid this by deferring. When transmissions from two or more stations overlap, the resulting contention is called a collision. Collisions occur only in half duplex mode, where a collision indicates that there is more than one station attempting to use the shared physical medium. In full duplex mode, two stations may transmit to each other simultaneously without causing interference.

# Status of IEEE Std 802.3.1-2013 and IEEE Std 802.3.2-2019

### Status of IEEE Std 802.3.1

• IEEE-SA Standards Board Operations Manual, 9.2 Removal from active status

Every IEEE Standard shall be considered for transfer to inactive status by the IEEE-SA Standards Board at the beginning of the next calendar year after it is ten years past its approval date (i.e., the standard will be labeled Inactive and reserved for historical reference).

[Note that IEEE Std 802.3.1-2013 may be revised even if "Inactive"]

# Possible path forward

- If we choose to revise IEEE Std 802.3.1, do we merely implement the open maintenance change (see 1383) or also update the MIB?
   [It was suggested that we revise IEEE 802.3.1 and update the MIB.]
- There is also an open maintenance request for IEEE Std 802.3.2 (see 1380)
- Should IEEE Std 802.3.2 also be amended or revised?
- Should the IEEE Std 802.3.2 data model also be updated?
   [It was suggested that we revise IEEE 802.3.2 and update the data model.]
- IEEE 802.3.1a (Revision to IEEE Std 802.3.1) PAR
- 5.5 Need for the Project: Ethernet network administrators need standard specifications for MIB modules so that different devices on their networks can be managed in a consistent fashion. Several amendments to IEEE Std 802.3 have been approved recently, and MIB modules specified in IEEE Std 802.3.1 must be updated to reflect these amendments.

### Possible next steps

- To revise IEEE Std 802.3.1-2013 and/or IEEE Std 802.3.2-2019, draft revision PARs need to be generated for consideration
- Volunteer(s) to assist in the generation of draft PARs are solicited
