Update on Maintenance Request #1232

Mr. Diab asked Mr. Barrass to give an update on the status of the request as Mr. Barrass had volunteered to contact the submitters at the November Maintenance Task Force meeting, specifically to allow them the opportunity to provide additional technical

analysis to determine impact from other optical parameters such as jitter, develop consensus within the 802.3 optical community, and discuss the process options / schedule for the request. Mr. Barrass reported that a presentation was being worked on and it will likely be submitted ahead of the next Maintenance meeting.

Mr. Barrass proposed a straw poll on whether the scope of this change is beyond Maintenance. Mr. Barrass subsequently withdrew his request for a straw poll in favor of the motion below.

Consolidated Edition Layout /TOC

Mr. Diab noted that the IEEE staff had asked for feedback on the layout (TOC) of the consolidated edition including whether or not to create a new section in the document. There was unanimous consensus to add a new section.

Mr. Diab turned the floor over to Mr. Law to review two proposals for the new section.

Mr. Law reviewed the following two proposals for the layout / TOC of the consolidated edition including predicted estimate page counts for each:

- Option 1: Place clause 75 through clause 90 and annex 75A through annex 86A in section six. A very rough estimate of page count for section six, with the existing section one through five pdf page count is:
 - o Section 1: 671
 - o Section 2: 790
 - o Section 3: 315
 - o Section 4: 586
 - o Section 5: 615
 - o Section 6: 548
- Option 2: Place clause 75 through clause 77, and associated annexes, in section five, since section five contains the other subscriber access network technologies. A very rough estimate of page count for section five and six, with the existing section one through four pdf page count is:
 - o Section 1: 671
 - o Section 2: 790
 - o Section 3: 315
 - o Section 4: 586
 - o Section 5: 784
 - o Section 6: 379

There was unanimous consensus for option 2.

Process and Timeline

Mr. Diab noted that the PAR for the revision was currently on the NesCom Continuous Processing agenda for the January 2011 NesCom telecon. The process and timeline were further refined including a suggestion by Mr. Frazier to go to Working Group ballot of the July plenary. A limited Task Force review out of the March plenary would be conducted. Scope limited to

- Checking the consolidated edition for conflicts
- Folding in the relevant maintenance requests

- Coordinating changes with .3.1 / OAM and delete GDMO
- Not a "traditional" full TF review with comment tool etc.

Mr. Diab also noted that he had received an offer from Mr. Anslow for assistance on the revisions. Mr. Diab requested that any individual interested to please contact him. Once the PAR is approved, based on the scope of work and any volunteers' time / constraints, any assignments for work / officers on the project would be announced at a subsequent maintenance meeting.

IEEE P802.3.1 Update

The Chair, Mr. Diab, asked if there was any other business. Mr. Frazier suggested an update on P802.3.1. Mr. Diab asked if there was any objection to adding this item to the end of the agenda. There was no objection to adding a discussion of P802.3.1 revision to the agenda.

Mr. Frasier reported that he expects that IEEE P802.3.1 may be ready for the March RevCom agenda; however, since the publication schedule is not urgent, the document will likely be submitted in June. As IEEE Std 802.3-related updates need to be incorporated in a future update of IEEE P802.3.1, Mr. Frasier plans to draft a new PAR for review at the March plenary meeting and submission to NesCom in June.
